
**(PROHIBITION OF DRIVING)(EXCEPT FOR LOCAL BUSES AND CYCLES)
ORDER 2008**

The County of Herefordshire District Council ("the Council") in exercise of its powers under sections 1 and 2 of the Road Traffic Regulation Act 1984 (referred to as "the 1984 Act"), the Road Traffic Act 1991 (as amended) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order:-

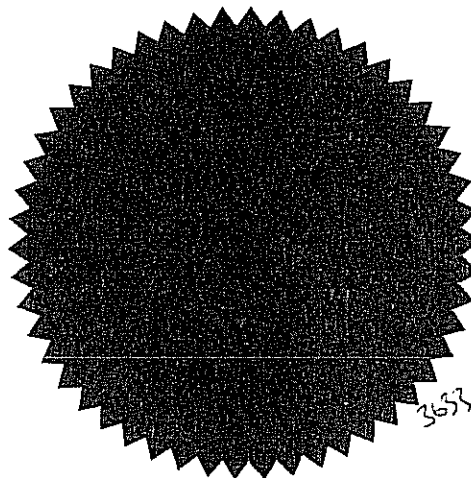
1. This Order shall come into operation on the 22nd day of February 2008 and may be cited as the County of Herefordshire District Council Saxon Court Site, The Avenue, (off Hoarwithy Road) Hereford (Prohibition of Driving)(Except for Local Buses and Cycles) Order 2008.
2. Save as provided in Article 3 of this Order no person shall except upon the direction or with the permission of a police officer in uniform or parking attendant in uniform (when authorised by statute to do so) cause or permit any vehicle to proceed along the length of The Avenue, Saxon Court, Hereford, from its junction with the western kerb line of Hoarwithy Road (C1261) for a distance of 47metres in a south westerly direction as shown for identification purposes only on the enclosed plan.
3. The restrictions imposed by Article 2 above shall not apply when vehicles are being used in connection with the following purposes:-
 - (i) fire brigade, ambulance or police
 - (ii) local service buses, fitted with suitable electronic tags
 - (iii) statutory undertakers
 - (iv) street cleansing or for purposes associated with the maintenance of the highway, street furniture or fabric of the highway
 - (v) pedal cyclists
- 4 Reference to any statutory provision herein shall include reference to any statutory modification or re-enactment thereof.

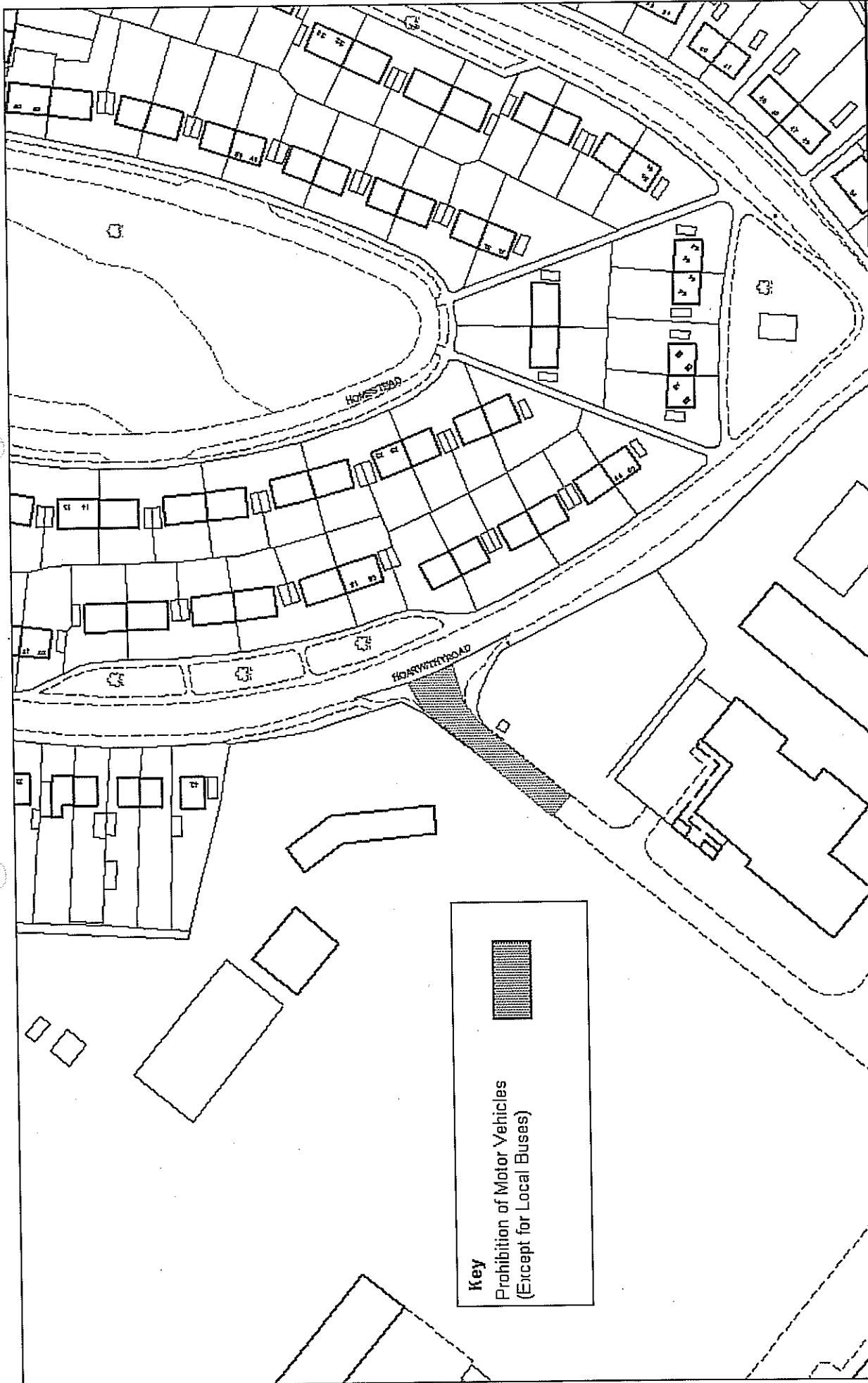
