

**NOTICE OF PROPOSAL (EIGN)**

Herefordshire Council hereby gives notice that in exercise of its statutory enabling powers it is proposing to make **THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (HEREFORD RESIDENTS PARKING) ORDER 2017**, the effect of which will be:

- A) To introduce no waiting at any time restrictions in the following lengths of road:
- 1) **Foley Street: Both Sides** - From the south-eastern kerbline of Ledbury Road to the southern boundary of 1 Foley Street; **Turning Head** - From the southern boundary of Beverley Court southwards around the turning head, across the access to the industrial estate and northwards to the southern boundary of 77 Foley Street.
- B) To introduce permit holders (zone 5)/limited waiting (max stay 1 hour, no return within 2 hours) 9am – 8pm restrictions in the following lengths of road:
- 1) **Foley Street: East Side** - From the southern boundary of 1 Foley Street to the southern boundary of 77 Foley Street; **West Side** - From the southern boundary of 1 Foley Street to the southern boundary of Beverley Court.
- C) To amend the existing permit holders/limited waiting bay in **Ledbury Road: North Side** - From 80m north-east of the north-eastern kerbline of Central Avenue north-eastwards for 27m, to permit holders (zone 5)/limited waiting (max stay 1 hour, no return within 2 hours) 9am – 8pm on all days.
- D) To standardise the terms, conditions and definitions across the residents parking zones in Hereford, where considered appropriate.
