

NOTICE OF PROPOSAL (HINTON & HUNDERTON)

Herefordshire Council hereby gives notice that in exercise of its statutory enabling powers it is proposing to make **THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (HEREFORD RESIDENTS PARKING) ORDER 2017**, the effect of which will be:

- A) To introduce no waiting at any time restrictions in the following lengths of road:
- 1) **Belmont Court:** *South & West Side* - From the western boundary of 4 Belmont Court to 54m south of the southern kerbline of Belmont Avenue.
 - 2) **Chestnut Drive:** *Both Sides* - From the south-eastern kerbline of Hinton Crescent south-eastwards for 10m.
 - 3) **Court Crescent:** *All Sides* - For its entire length.
 - 4) **Hinton Avenue:** *East Side* - From the southern kerbline of Hinton Crescent southwards for 10m; *West Side* - From the southern kerbline of Hinton Crescent southwards for 32.5m.
 - 5) **Hinton Crescent:** *Both Sides* - From the south-western kerbline of Hinton Road (south-eastern junction) south-westwards for 10m; *Outer Side* - From 17.5m south-west of the south-western kerbline of Chestnut Drive to 10m north-east of the north-eastern kerbline of Chestnut Drive, From 10m west of the western kerbline of Hinton Avenue to 18m east of the eastern kerbline of Hinton Avenue and From 10m north of the northern kerbline of Hollybush Walk to 20m south of the southern kerbline of Laburnum Grove.
 - 6) **Hinton Road:** *Both Sides* - From 15m south-east of the eastern kerbline of Hinton Crescent to 2m north-west of the extended eastern boundary of 56-62 Hinton Crescent.
 - 7) **Laburnum Grove:** *Both Sides* - From the western kerbline of Hinton Crescent westwards for 10m.
- B) To introduce permit holders (zone J)/limited waiting (max stay 1 hour, no return 2 hours) 9am – 8pm restrictions in the following lengths of road:
- 1) **Belmont Avenue:** *North Side* - From 28m east of the western boundary of 56/58 Belmont Avenue to 0.5m west of the western boundary of 1 Belmont Square; *South Side* - From 11m east of the eastern kerbline of Springfield Avenue eastwards to 17m west of the western kerbline of Belmont Court, From 12.5m east of the eastern kerbline of Belmont Court eastwards for 30.5m and From 5.5m east of the extended western boundary of 56/58 Belmont Avenue to 18m west of the western kerbline of Springfield Avenue.
 - 2) **Belmont Court:** *East & South Side* - From 8m south of the southern kerbline of Belmont Avenue southwards and westwards to the western boundary of 4 Belmont Court; *West Side* - From 9m south of the southern kerbline of Belmont Avenue southwards for 45m.
 - 3) **Hinton Crescent:** *Inner Side* - From 10m south-west of the south-western kerbline of Hinton Road (south-eastern junction) to 10m south-west of the south-western kerbline of Hinton Road (north-western junction); *Outer Side* - From 20m south of the southern kerbline of Laburnum Grove to 10m west of the western kerbline of Hinton Avenue, From 10m south-west of the south-western kerbline of Hinton Road (south-eastern junction) to 10m north-east of the north-eastern kerbline of Chestnut Drive, From 12m south of the southern kerbline of Hinton Road to 10m

north of the northern kerblines of Hollybush Walk and From 17.5m south-west of the south-western kerblines of Chestnut Drive to 18m east of the eastern kerblines of Hinton Avenue.

- 4) **Oak Avenue:** *North-West Side* - From the south-western kerblines of Hinton Crescent to the boundary of 10/12 Oak Avenue; *South-East Side* - From the south-western kerblines of Hinton Crescent to the boundary of 9/7 Oak Avenue.

C) To amend the following existing permit holders only bays to permit holders only (zone 8) 8am – 8pm on all days:

- 1) **Wye Street:** *North Side* - From 16m east of the eastern kerblines of St Martins Street eastwards for 10m and From 48m east of the eastern kerblines of St Martins Street eastwards to 7m west of its closed end.

D) To amend the following existing permit holders/limited waiting bays to permit holders (zone 8)/limited waiting (max stay 1 hour, no return within 2 hours) 8am – 8pm on all days:

- 1) **St Martins Street:** *East Side* - From 10m south of the southern kerblines of Wye Street to 37.5m north of the northern kerblines of St Martins Avenue; *West Side* - From 20.5 metres south of the southern kerblines of Wye Street southwards for 37m.

E) To formalise the no stopping on entrance marking (SCHOOL-KEEP-CLEAR) 8am – 4.30pm Monday to Friday restriction in **Belmont Avenue:** *North Side* - From 1.5m east of the western boundary of 56/58 Belmont Avenue eastwards for 26.5m.

F) To standardise the terms, conditions and definitions across the residents parking zones in Hereford, where considered appropriate.
