

NOTICE OF PROPOSAL (COLLEGE)

Herefordshire Council hereby gives notice that in exercise of its statutory enabling powers it is proposing to make **THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (HEREFORD RESIDENTS PARKING) ORDER 2017**, the effect of which will be:

- A) To introduce no waiting at any time restrictions in the following lengths of road:
- 1) **Barrs Court Road:** *East Side* - From its junction with College Road to 11m north of the extended northern kerbline of Huskinson Drive; *West Side* - From its junction with College Road to 15m south of the southern kerbline of Huskinson Drive.
 - 2) **Bulmer Avenue:** *North Side* From 10m east of the north-eastern kerbline of Barrs Court Road to 10m east of the south-eastern kerbline of Geoffrey Avenue; *South/South-East Side* - From 10m east of the north-eastern kerbline of Barrs Court Road eastwards for 5m, From 10m west of the western kerbline of Esmond Road to 10m east of the eastern kerbline of Esmond Road and From 3m north of the northern boundary of 72 Bulmer Avenue to its junction with Frank Owen Court.
 - 3) **College Green:** *Both Sides* - From the north-western kerbline of College Road north-westwards for 10m.
 - 4) **College Road:** *North-West Side* - From the north-eastern kerbline of Kingsway north-eastwards for 18.5m and From the south-western boundary of 57 College Road to 10m north-east of the north-eastern kerbline of College Green; *South-east* - From the extended south-western boundary of 1 College Road to 18.5m north-east of the extended north-eastern kerbline of Kingsway and From 10m south-west of the southern kerbline of Penn Grove Road to 10m north of the north-eastern kerbline of Penn Grove Road (northern junction).
 - 5) **Esmond Road:** *North-West Side* – From 10m north-east of the north-eastern kerbline of Barrs Court Road to the southern kerbline of Bulmer Avenue; *South-East Side* - From the south-western kerbline of Bulmer Avenue south-westwards for 10m.
 - 6) **Frank Owen Court:** *All Sides* - For its entire length (except for south-west side 17.5m north-west of the south-eastern closed end of Frank Owen Court north-westwards 5.5m).
 - 7) **Geoffrey Avenue:** *Both Sides* - From the north-eastern kerbline of Bulmer Avenue north-eastwards for 10m; *North-West Side* - From 10m south-west of the south-western kerbline of Lingen Avenue to its junction with Lingen Avenue.
 - 8) **Huskinson Drive:** *Both Sides* - From the south-western kerbline of Barrs Court Road westwards for 10m.
 - 9) **Lingen Avenue:** *Both Sides* - From the southern kerbline of Penn Grove Road southwards to the extended northern boundary of 36 Lingen Avenue and From the northern kerbline of Bulmer Avenue northwards for 10m; *North-East Side* - From the north-western kerbline of Lingen Avenue north-westwards for 10m; *North-West Side* - From the north-eastern kerbline of Lingen Avenue north-eastwards for 10m; *South-West Side* - From the north-western kerbline of Geoffrey Avenue north-westwards for 10m.
- B) To introduce no waiting 9am – 6pm Monday to Saturday in **College Road:** *North-west Side* - From 18.5m north-east of the north-eastern kerbline of Kingsway to the extended south-western boundary of 57 College Road.
- C) To introduce permit holders (zone 15)/limited waiting (max stay 1 hour, no return within 2 hours) 9am – 6pm Monday to Saturday restrictions in the following lengths of road:
- 1) **College Road:** *South-East Side* - From 18.5m north-east of the extended north-eastern kerbline of Kingsway to 10m south-west of the southern kerbline of Penn Grove Road (southern junction).
 - 2) **Bulmer Avenue:** *North & North-West Side* - From 10m east of the south-eastern kerbline of Geoffrey Avenue to its junction with Frank Owen Court; *South Side* - From 15m north-

east of the north-eastern kerbline of Barrs Court Road to 10m west of the western kerbline of Esmond Road; *South & South-east Side* - From 10m east of the eastern kerbline of Esmond Road to 3m north of the northern boundary of 72 Bulmer Avenue.

- 3) **Bulmer Avenue (cul-de-sac opposite 72 Bulmer Avenue): All Sides** - For its entire length.
- 4) **Esmond Road: South-East Side** - From 10m north-east of the north-eastern kerbline of Barrs Court Road to 10m south-west of the south-western kerbline of Bulmer Avenue.
- 5) **Frank Owen Court: South-West Side** - From 17.5m north-west of the south-eastern closed end of Frank Owen Court north-westwards 5.5m.
- 6) **Geoffrey Avenue: North-West Side** - From 10m north-east of the north-eastern kerbline of Bulmer Avenue to 10m south-west of the south-western kerbline of Lingen Avenue; *South-East* - From 10m north-east of the north-eastern kerbline of Bulmer Avenue to its junction with Lingen Avenue.
- 7) **Lingen Avenue: North-West Side** - From 10m north-east of the north-eastern kerbline of Bulmer Avenue north-eastwards to 10m north-west of the north-western kerbline of Lingen Avenue and From 10m north-east of the north-eastern kerbline of Lingen Avenue to the extended northern boundary of 36 Lingen Avenue; *South-East Side* - From 10m north-east of the north-eastern kerbline of Bulmer Avenue north-eastwards to 10m north-west of the north-western kerbline of Geoffrey Avenue and From its junction with Geoffrey Avenue north-eastwards to the extended northern boundary of 36 Lingen Avenue.

D) To standardise the terms, conditions and definitions across the residents parking zones in Hereford, where considered appropriate.
