The HRA for Leominster NDP will need to be revisited in light of the recent Court of Justice of the European Union People over Wind and Peter Sweetman vs Coillte judgement.

There are currently 20 HRAs which this is affecting and we are working thought them in priority order depending on their current status and progress.

All revised HRA will be subject to a 5 week consultation, therefore it is anticipated that this will not be concluded for the Leominster NDP to the 17 September 2018.

Obviously this will have an impact on the examination timescales. Depending on the additional work required on other elements of the examination, I am aware you are still awaiting feedback regarding the Local Green Spaces, it might be that the examination will need suspending until the conclusion of the HRA review.
