## Section 2 document guidance

Visitor permits – these are not vehicle specific (i.e. without a registration number printed on) and can be used on any eligible vehicle. Only one is permitted for each property (this is part of your overall allowance). Therefore, no further details are needed.

Vehicle permits – these are permits issued to a vehicle. The allowance varies from scheme to scheme, see table above for the number permitted in the zone that you are applying for.

These will require evidence of ownership of the vehicle.

The following are **acceptable**:

- Registration documents – the vehicle **MUST** be registered in the applicant's name and at the address for which the application is being made. We may consider a receipt of purchase provided the receipt/invoice shows the applicant's name and address and the date the vehicle was purchased, which must be within 3 weeks of the application date.
- If the vehicle is a company car you will be required to provide either a confirmation letter from the company that you are the sole user of the vehicle and it is in your possession at all times or a copy of the lease/hire agreement.

The following are **not acceptable**:

- Insurance documentation
- New Keeper slip

Where evidence is being provided this can either be by post or email and can be a photocopy / scan of a document, it can also be a photograph. Please ensure that all relevant information is visible. Attach this to the postal application or to the email.

## Section 3 residency proof guidance

All applications require a proof of residency check, for either type of permit.

You can opt to allow us to check the council tax register by ticking the box. The applicant must be listed as being liable for the council tax at the eligible property.

The following are **acceptable**:

- Current utility bill (no more than 3 months old)
- Council Tax demand (current year only)
- Tenancy agreement
- Landline telephone bill

The following are **not acceptable**:

- Bank statement
- Mobile telephone bill
- Official letters addressed to the applicant e.g. child tax credit, Inland Revenue information, Job Seekers Allowance confirmation

Where evidence is being provided this can either be by post or email and can be a photocopy / scan of a document, it can also be a photograph. Please ensure that all relevant information is visible. Attach this to the postal application or to the email.



## Section 4 fees guidance

Fee:

- 1<sup>st</sup> permit - £30.00 – (new, renewal, duplicate (vehicle only) or visitor)
- 2<sup>nd</sup> permit - £30.00
- 3<sup>rd</sup> Permit - £75.00
- 4/5<sup>th</sup> Permit - £100.00 each
- £10.00 for a replacement permit to change a vehicle registration number

Payment can be made by **credit or debit card** by providing an email address where a secure link to take a payment can be provided once the permit application has been considered.

Payment can be made by **cheque** (made payable to Herefordshire Council) and enclosed in applications made by post.
