# **Section 1: Monitoring the Local Development Scheme**

#### Introduction

- 1.1 This section reports on progress in achieving the timetable and milestones set out in the Council's Local Development Scheme (LDS) August 2018.
- 1.2 Each proposed Local Development Document identified in the LDS is listed below, with a brief review of progress. The LDS was updated in August 2018 forms the basis for monitoring Development Plan progress in 2019.

## Summary of Progress up to April 2019.

### Local Plan - Core Strategy

1.3 The LDS anticipated that a review of the Core Strategy would begin in the summer of 2019. Initial work is focussed on reviewing existing plan documents against the revised national planning policy framework and identification of evidence requirements. The next version of the LDS will set out the timetable for plan preparation in more detail.

#### **Hereford Area Plan**

1.5 The LDS anticipated a consultation on a draft plan/preferred options in the Winter 2018. However, preparation of this document has not yet happened. New Council administration (Post May 2019) considering key elements of transport infrastructure in Hereford will result in a revised timetable being set out in subsequent version of the LDS.

#### **Minerals and Waste Local Plan**

1.6 The LDS suggests that consultation of the draft plan was anticipated for the summer of 2018 but consultation actually was undertaken starting in January 2019. The revised timetable will be set out in the next version of the LDS.

### **Travellers' Development Plan Document**

1.7 The 2018 LDS anticipated adoption in the autumn of 2018 but delays in the examination process, including additional consultation and further hearings delayed the adoption until October 2019. Although strictly outside of the monitoring period it is reported below.

### Rural Areas Sites Allocation Development Plan Document (RASADPD)

1.8 The LDS makes reference to the preparation of a Rural Areas Sites Allocation Development Plan Document. An issues and options consultation was undertaken for the RASADPD in June/July 2017, and a call for sites was undertaken in 2018, but as with the Hereford Area Plan a revised timetable will be prepared following the decision of the Council regarding key elements of infrastructure in Hereford. Progress will be reported in future monitoring reports.
