

What you need to do next

If you are accepting the school offered you do not need to do anything. We shall assume you are accepting this place unless we hear from you. The Headteacher/Principal of this school will write to you at a later date regarding the admission arrangements.

Please note - If the school offered is within another local authority you <u>must</u> contact that local authority to accept the school place. See contact details further below.

If you are declining the school offered you can either write/e-mail (see above for address/e-mail) stating that you are declining the place offered and details of where your child will be starting his/her education in September 2020.

Please note - We will not be able to withdraw the school that has been offered unless we receive an email or written confirmation from yourself stating where your child will be in education from September 2020.

If you wish to request a place at an alternative school (even if that school has reached its published admissions number or has a waiting list) please write/e-mail stating the name of your child and what school(s) you are requesting for the attention of the Secondary Admissions Officer no later than Friday 13 March 2020 (see above for address/e-mail).

All change of preference requests with any late applications will be considered and places will be allocated according to the oversubscription criteria relevant to that school. You will be informed of the outcome week commencing 23 March 2020 if not before. Our ability to meet your request will depend on the level of demand and places available.

Any subsequent late applications and preference changes after the 13 March 2020 will be dealt with as and when they are received and we will aim to inform you of the outcome within five working days.

If you wish to appeal against the refusal of a place at a school in Herefordshire you have the right to do so if your child's higher preference(s) have not been met. A separate appeal form should be completed for each school you wish to appeal for. For further information on appealing and a downloadable copy of the appeal form please visit
