

NOTICE OF MAKING

HEREFORDSHIRE COUNCIL

(B4349 KINGSTONE) (20MPH, 30MPH AND 40MPH SPEED LIMIT)

ORDER 2020

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under section 82 & 84 of the Road Traffic Regulation Act 1984 has made the above-named order the effect of which is as follows: **To maintain a 20mph speed limit on the following stretch of road; B4349** from a point 300 metres north east of its junction with B4348 at Kingstone to a point 810 metres north east of its junction with B4348 and **U73446 Tippetts Meadow** for its entire length. **To introduce a 30mph speed limit on the following stretch of road; B4349** from a point 215 meters southwest of its junction with C1221 to a point 422 meters southwest of its junction with C1221 and **B4349** from a point 100m northeast of its junction with C1221 to a point 3m west of its junction with C1221. **To introduce a Restricted Road speed limit on the following roads; B4349** from a point 3m west of its junction with C1221 to a point 215 meters southwest of its junction with C1221, **B4349** from a point 422 meters southwest of its junction with C1221 to a point 503 meters southwest of its junction with C1221, **U73221 Coldstone Cross** for its entire length. **To maintain a 40mph speed limit on the following stretch of road; B4349** from a point 188 metres north east of its junction with B4348 at Kingstone to a point 300 metres north east of its junction with B4348. **To revoke the following existing speed limit orders; THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (B4349 KINGSTONE) (20MPH SPEED LIMIT) ORDER 2004 & THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (B4349 KINGSTONE) (40 MPH SPEED LIMIT) ORDER 2004.**

This Order will come into operation on 31 December 2020.

Due to the difficulty for local authorities to make documents relating to Proposed Traffic Regulation Orders available for public inspection in their offices during the coronavirus pandemic, **The Traffic Orders Procedure (Coronavirus) (Amendment) (England) Regulations 2020**, (which came into force on 23 May 2020) have been introduced to enable local authorities to put alternative arrangements in place to make documents available to the public. The following alternative arrangements are in place to allow the public to view or obtain copies of documents giving further details of this Order:

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with that person may, within six weeks from the date the Order was made, apply for the purpose to the High Court.

Any representations received by the Council may be imparted to third parties. We will keep your data for up to 7 years. Your information may be shared with other Balfour Beatty teams within Herefordshire and Herefordshire Council in order to provide you with the service. Individuals have a number of rights under data protection law, including the right to request their information. ROAD TRAFFIC REGULATION ACT 1984

HEREFORDSHIRE COUNCIL (B4349 KINGSTONE) (20 MPH, 30 MPH AND 40 MPH SPEED LIMIT) ORDER 2020

The County of Herefordshire District Council, known as Herefordshire Council in exercise of its powers under section 82 and 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act of 1984 (referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act hereby makes the following Order:

1. The Order shall come into operation on *31 December* 2020 and may be cited as HEREFORDSHIRE COUNCIL (B4349 KINGSTONE) (20 MPH, 30 MPH AND 40 MPH SPEED LIMIT) Order 2020".
2. For the purposes of section 84 of the said Act - No person shall drive a motor vehicle at a speed in excess of **20 mph** on the following length of road;
 - **B4349** between a point 300 metres north east of its junction with B4348 at Kingstone and a point 810 metres north east of its junction with B4348
 - **U73446 Tippetts Meadow** for its entire length
3. For the purposes of section 84 of the said Act - No person shall drive a motor vehicle at a speed in excess of **30 mph** on the following length of road;
 - **B4349** between a point 215 meters southwest of its junction with C1221 and a point 422 meters southwest of its junction with C1221.
 - **B4349** between a point 13 meters southwest of its junction with C1221 and a point 100 meters northeast of its junction with C1221.
4. For the purposes of section 84 of the said Act, no persons shall drive a motor vehicle in excess of **40 mph** on the following length of road;
 - **B4349** between a point 188 metres north east of its junction with B4348 at Kingstone and a point 300 metres north east of its junction with B4348
5. The lengths of roads specified below shall be **restricted roads** at **30 mph** for the purposes of section 82 of the said Act;
 - **B4349** between a point 13 metres southwest of its junction with C1221 and a point 215 meters southwest of its junction with C1221
 - **B4349** between a point 422 meters southwest of its junction with C1221 and a point 810 metres north east of its junction with B4348

- **U73221 Coldstone Cross** for its entire length

6. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
7. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the following Orders (and the provisions contained in any other previous Speed Limit Orders) that relate to the lengths of road subject to this Order which are in operation prior to the date mentioned in Article 1 of this Order will be revoked in their entirety from the date mentioned in the said Article 1:

THE COUNTY OF HEREFORDSHIRE DISTRICT COUNCIL (B4349 KINGSTONE) (40 MPH SPEED LIMIT) ORDER 2004.

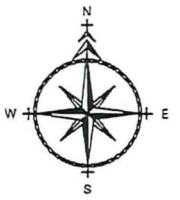


-  20 mph speed limit

HEREFORDSHIRE COUNCIL

(B4349 KINGSTONE) (20MPH, 30MPH AND 40MPH SPEED LIMIT)

ORDER 2019
