1 Introduction

- 1.1 This Screening Assessment relates to a Neighbourhood Development Plan that is considered to be in general conformity with higher level strategic plans, such as the Herefordshire Core Strategy and the National Planning Policy Framework. The screening stage involves assessing broadly whether the final Neighbourhood Plan is likely to have a significant effect on any European site(s).
- 1.2 Linton Parish Council has produced a Neighbourhood Development Plan for Linton, in order to set out the vision, objectives and policies for the development of the area up to 2031. This HRA reviews the draft Linton Plan (September 2019).
- 1.3 The NDP has a designated a settlement boundary for Linton, Gorsely and Bromsash to meet the growth requirements of the strategic policies. It provides eleven general criteria policies that clarify and given more detail to those within the Herefordshire Core Strategy. The plan does not allocate sites. This requires a high level screening assessment to build upon the HRA Screening Assessment Report for the Core Strategy. It should be read in combination with the Core Strategy Habitat Regulations Assessment Report and ensures that there will not be any significant impacts upon Natura 2000 sites.
- 1.4 The map below shows Linton Neighbourhood Area to with the European Sites highlighted.



2 The requirement to undertake Habitats Regulations Assessment of neighbourhood plans

- 2.1 The requirement to undertake HRA of development plans was confirmed by the amendments to the “Habitats Regulations” published for England and Wales in July 2007 and updated in 2013. Therefore, when preparing its NDP, Garway Parish Council is required by law to carry out an assessment known as “Habitats Regulations Assessment”. It is also a requirement in Regulation 32 schedule 2 of the Neighbourhood Planning Regulations 2012.
- 2.2 Article 6(3) of the EU Habitats Directive provides that:
Any plan or project not directly connected with or necessary to the management of the [European] site but likely to have a significant effect thereon, either individually or in combination with other plans or projects, shall be subject to appropriate assessment of its implications for the site in view of the site's conservation objectives. In the light of the conclusions of the assessment of the implications for the site and subject to the provisions of paragraph 4, the competent national authorities shall agree to the plan or project only after having ascertained that it will not adversely affect the integrity of the site concerned and, if appropriate, after having obtained the opinion of the general public.
- 2.3 HRA is an impact-led assessment and refers to the assessment of the potential effects of a neighbourhood plan on one or more European sites, including Special Protection Areas (SPAs) and Special Areas of Conservation (SACs):
- **SPAs** are classified under the European Council Directive ‘on the conservation of wild birds’ (79/409/EEC; ‘Birds Directive’) for the protection of **wild birds and their habitats** (including particularly rare and vulnerable species listed in Annex 1 of the Birds Directive, and migratory species).
 - **SACs** are designated under the Habitats Directive and target **particular habitats** (Annex 1) and/or species (Annex II) identified as being of European importance.
- 2.4 For ease of reference during HRA, general practice has been that these three designations are collectively referred to as either **Natura 2000** or **European sites**. This means that a Screening Assessment is carried out with regard to the Conservation Objectives of the European Sites and with reference to other plans or projects to identify if any significant effect is likely for any European Site.
- 2.5 Herefordshire Council is aware of the recent judgement (People over Wind, Peter Sweetman vs Coillte). The Court of Justice of the European Union (CJEU) ruled that Article 6(3) of the Habitats Directive must be interpreted as meaning that mitigation measures should be assessed within the framework of an appropriate assessment and that it is not permissible to take account of measures intended to avoid or reduce the harmful effects of the plan on a European site at the screening stage. The initial screening undertaken in August 2013 and concluded that a full HRA would be required. Mitigation was not taken into account at this stage.
- 2.6 The Co-operation Mobilisation (The Dutch case) ruling will also have an impact on Herefordshire in the areas within the catchment of the River Lugg. This will be covered in section 4.
- 2.7 The purpose of this HRA report is to detail the findings of the screening of the proposed minor changes to policies following the revisions after the Reg14 consultations. It will also take into account the implications of Sweetman and the Dutch Case on the NDP.

3 Methodology

- 3.1 Although the Linton NDP is not directly regarding the management of any European sites, it does include proposals for development which may affect European sites. Therefore, it is necessary under Regulation 102(1)(a) of the Habitats Regulations 2010 to undertake screening for likely significant effects on European sites.
- 3.2 The HRA of neighbourhood plans is undertaken in stages and should conclude whether or not a proposal or policy in a neighbourhood plan would adversely affect the integrity of the site in question. This is judged in terms of the implications of the plan for a site's 'qualifying features' (i.e. those Annex I habitats, Annex II species, and Annex I bird populations for which it has been designated) and are measured with reference to the conservation objectives for those qualifying features as defined by Natural England.
- 3.3 The first process is to undertake an initial screening report to determine the need to undertake the requirement for a HRA, this initial screening identifies whether the Plan could impact upon any European site that could be within the Neighbourhood Area or nearby.
- 3.4 If a European Site is within the Neighbourhood Area or the Neighbourhood Area could impact upon a European site then this will need to be taken into account and a full screening assessment will need to be undertaken.
- 3.5 The full screening stage consists of a description of the plan, identification of potential effects on European Sites, assessing the effects on European Sites. For Neighbourhood Plans the outcome should demonstrate there are no likely effects upon the European sites. If any likely effects occur then there will need to be amendments to the NDP made and be re-screened until all likely effects have been addressed.

4 Results of the Initial Screening Report and qualifying features of the European Sites

- 4.1 The initial Screening report (**March 2018**) found that the Neighbourhood Area the hydrological catchment of the River Wye (including the River Lugg) SAC and is 9.8km (within 10km) of the Wye Valley Woodlands SAC and 2.8km from the Wye Valley and Forest of Dean Bat Sites SAC. Therefore a full screening assessment is required.
- 4.2 There is also a duty under the Water Framework Directive to ensure that proposals for growth do not adversely affect the river water quality and this included the associated watercourses flowing into the rivers.

Site integrity of the River Wye (including the River Lugg) SAC

- 4.3 The issues associated with maintaining the sites integrity include water levels and flow, water quality, eutrophication (nitrogen enrichment), sedimentation, disturbance and species maintenance.
- 4.4 The River Wye SAC can be sensitive to changes in water quantity and quality. As outlined within the Habitat Regulation Assessment to the Herefordshire Core Strategy, the water supply in this

area comes from Dwr Cymru Welsh Water (DCWW) and no likely significant effects on European sites as a result of changes in water quality are expected in relation to the proportional growth outlined with the Herefordshire Core Strategy.

- 4.5 Sections of the River Wye SAC where the water quality targets are already exceeding are subject to measure to reduce nutrients in line with the targets. In light of the interpretation of the Dutch Case where a European Site is falling its water quality objectives and is classified as unfavourable condition, there is limited scope for the approval of additional damaging effects and measures that can't be relied or are uncertain.
- 4.6 In relation to water quality, Policy SD4 of the Herefordshire Core Strategy indicates that any development should not undermine the achievement of water quality targets within the county's rivers. This should ensure that developments within the area can be accommodated within existing water discharge permits would not be likely to have a significant effect upon the River Wye SAC. This position is confirmed within the HRA of the Core Strategy in April 2015.
- 4.7 Dwr Cymru Welsh Water (DCWW) nor Severn Trent indicated any issues with the capacity of any Sewerage Treatment works serving the Linton Gorsley or Bromsash area. Any new development will need to be in line with Core Strategy Policy SD4.

Site integrity of the Wye Valley and Forest of Dean Bat Sites SAC and Wye Valley Woodlands SAC

- 4.8 The Greater Horseshoe Bat and Lesser Horseshoe bat feature within the Wye Valley and Forest of Dean Bat Sites. The Greater Horseshoe Bat are known to migrate between 20-30km between their summer and winter roosts whereas the Lesser Horseshoe migrate 5km and 10km between their summer and winter roosts. The Lesser Horseshoe Bat is vulnerable to disturbance, noise and vibration, light pollution and habitat lost.
- 4.9 NDPs sites within 10 km of the Wye Valley and Forest of Dean Bat Sites will need to consider development impact to these species and their habitats. NDPs closest to the Wye Valley Woodlands will need to consider: Woodland habitat buffer. Lesser Horseshoe Bat: Old buildings; woodland locations; sheltered valleys, extensive deciduous woods or dense scrub, close to roost sites. In areas of fragmented habitats, linear habitats such as hedgerows are important corridors. Vulnerable to loss or disturbance of both summer and winter roosts and removal of linear habitat.
- 4.10 The issues associated with maintaining the sites integrity include impact of development result in changes in landscape and townscape. As outlined within the Habitat Regulation Assessment to the Herefordshire Core Strategy, impact on European sites is dependent on scale and proximity to the European sites.
- 4.11 In relation to impact on biodiversity and important species, Policy LD2 of the Herefordshire Core Strategy indicates that any development should conserve, restore and enhance biodiversity and geodiversity assets of Herefordshire. Development within close proximity to internationally and local designated sites will need to incorporate sympathetic design components to enhance their nature conservation interests.

Summary of NDP effect on site integrity

- 4.12 For full details of the two relevant SAC attributes which contribute to and define their integrity and vulnerable data see Appendix 1 of the Linton Initial Screening Report. The Initial Screening Report, March 2018, can be found in Appendix 1 of this HRA report.
- 4.13 This information made it possible to identify the features of each site which determine site integrity, as well as the specific sensitivities of each site, therefore enabling later analysis of how the potential impacts of the Linton Neighbourhood Plan may affect site integrity.
- 4.14 The initial screening assessment indicated that a full screening assessment is required to assess the likelihood of significant effects on the River Wye (including the River Lugg) SAC, the Wye Valley Woodlands SAC and Forest of Dean Bat Sites SAC of the policies within the Linton NDP.
- 4.15 As the Linton NDP progresses from options onto their NDP policies, the Plan will need to identify ways in which the least effect on the Wye Valley SAC, Wye Valley Woodlands SAC and Forest of Dean Bat Sites SAC could be achieved, alongside taking forward the preferred options from the consultation from the community. If a majority of these options are taken forward either as standalone policies or in combination with other policies then the mitigation from these options will help to counter balance the effect of all new development within the Parish. A list of the options and site options assessed can be found in Appendix 1, and the Assessment matrix for the options can be found Appendix 2.

5 Description of the Linton Neighbourhood Development Plan

- 5.1 The draft Linton NDP presents detailed policies for development in the Neighbourhood Area, which is equivalent to the group parish boundary, up to 2031. The Plan begins by introducing its preparation and highlighting its issues.
- 5.2 The NDP then details the vision for the parish over the Plan period together with a number of primary objectives to realise that vision:
- **Objective 1: environment and heritage**
To protect and maintain the natural and historic environment of the parish, in particular its designated areas, sites and buildings; and its landscape character, especially views and vistas, ensuring access to these through the public footpath network.
 - **Objective 2: housing**
To provide a range and choice of new homes, sensitively located and to meet the needs of all sections of the community. These homes should be built at a scale and density designed to respect and enhance the character of the parish.
 - **Objective 3: infrastructure and roads**
To support the provision of improved infrastructure in line with new development, including roads/pavements; public transport; the sewerage system; surface water drainage; mobile telephony and broadband. Infrastructure to reduce carbon dependence will also be encouraged through seeking appropriate alternative energy methods. To address traffic issues including the speed of vehicles through the villages; the effect of traffic noise on amenity; and the need for safer environments for all road users.
 - **Objective 4: community services and facilities**
To ensure that community services and facilities are retained and enhanced as much as possible, and that community spirit and involvement is actively encouraged.

- Objective 5: economic development and employment
To support and encourage the development or expansion of small and home-based businesses and farming

5.3 From these 5 objectives around housing, environment and facilities they have development into specific policies:

Option 1: not to prepare a Neighbourhood Development Plan, relying instead on the Core Strategy and the Rural Areas Sites Allocations DPD

Option 2: use a criteria-based Plan incorporating a general development strategy

Option 3: allocate sites to address the minimum housing requirement

Option 4: define settlement boundaries for Bromsash, Gorsley and Linton without allocating sites

Option 5: define settlement boundary for Bromsash, Gorsley and Linton and allocate sites in or adjacent to these villages

5.4 The initial options for the NDP (refer to appendix 2) were assessed to determine their environmental impact that could affect the River Wye SAC, the Wye Valley Woodland SAC and Forest of Dean Bat Sites SAC. Of the five options put forward the 'no NDP / do nothing' option was not considered viable for the parish. All of which indicated towards growth however all the options would be seeking to provide proportional growth in line with the Core strategy and are therefore unlikely to have a significant impact on the three SACs

5.5 As Linton Neighbourhood Plan progressed from options to draft NDP policies, the Plan needed to identify ways in which the least effect on the two European sites could be achieved, alongside taking forward the preferred option from the consultation from the community.

5.6 The NDP also sets out 11 general policies on various topics based on the objective headings above, these include:

- Policy BGL 1: Sustainable Development
- Policy BGL2: Natural environment
- Policy BGL3: Historic Environment
- Policy BGL4: Building design
- Policy BGL5: Renewable and low carbon energy
- Policy BGL6: Settlement boundaries
- Policy BGL7: Housing mix
- Policy BGL8: Community services and facilities
- Policy BGL9: Local Green Space
- Policy BGL10: Small-scale employment development
- Policy BGL11: Agricultural development

6.0 Assessments undertaken to date of the emerging Linton NDP policies

- 6.1 Regulation 102 of the Habitats Regulations 2010 requires that a Screening Assessment be undertaken, in order to identify the 'likely significant effects' of an NDP. Accordingly, a screening matrix was prepared and this determined the extent to which any of the policies within the Linton NDP would be likely to have a significant effect on the River Wye SAC, Wye Valley Woodlands and Forest of Dean Bat Sites SAC.
- 6.2 In light of the *Sweetman* case all policies have been reviewed to ensure compliance with the ruling. The finding can be found in appendix 3.
- 6.3 The findings of the screening matrix can be found in the appendix. Positive or negative outcomes were used to record the outcome of likely impacts of the policies on the European site and its qualifying habitats and species as shown in the table 1 below.

Key of outcomes of HRA screening assessment	
Negative	There are likely to be significant effects
Positive	Significant effects are unlikely

- 6.4 Following the recent *Sweetman* judgement, it is not permissible to take account of measure intended to avoid or reduce the harmful effects of the plan on the River Wye SAC and Wye Valley Woodlands SAC, at this final screening stage. Any likely significant effects would require an Appropriate Assessment to be required.

Screening of the draft plan (Reg14)

- 6.5 None of the draft Linton Neighbourhood Plan policies were concluded to be likely to have a significant effect on the River Wye SAC, Wye Valley Woodlands SAC and Forest of Dean Bat Sites SAC.
- 6.6 Policy LD2 of the Core Strategy indicates that any development should conserve, restore and enhance biodiversity and geodiversity assets of Herefordshire. Development within close proximity to internationally and local designated sites will need to incorporate sympathetic design components to enhance their nature conservation interests.
- 6.7 Linton NDP does not allocate sites.
- 6.8 In addition, as any development will require to meet the criteria of Policy LD2, legal opinion has indicated that an AA is not required. The sites likely impact on the SACs can be determined further at planning application stage when further details of the proposed housing schemes are known.
- 6.9 Dwr Cymru Welsh Water (DCWW) have indicated that there is headroom to accommodate growth within the Core Strategy. Although located adjacent to the River Wye SAC, the level of phosphate is not an issue which is causing concern within Linton and NMP actions are unlikely to be required.
- 6.10 In addition, the review of the Nutrient Management Plan for the River Wye SAC should ensure that development within Herefordshire which can be accommodated within existing water discharge permits would not be likely to have a significant effect upon the River Wye SAC.

- 6.11 No mitigation measures have been included within the screening of the policies of the NDP. Policies of the Core Strategy and the NDP will form part of the development plans. A key requirement of the Core Strategy is to meet the Water Framework Directive.
- 6.12 This review has concluded that the policies are unlikely to result in significant effects on the River Wye SAC and the Wye Valley woodland SAC ***It is therefore concluded that the Linton Plan will not have a likely significant effect on the aforementioned three European Sites.***

7 Screening of modifications to the NDP (Reg16)

- 7.1 The submission Linton NDP has been revised following the consultation. 5 policies have been amended. This has included clarification of wording rather than any fundamental changes in direction or stance. One Local Green Space has been deleted.
- 7.2 The following policies have been amended but have not been reassessed:
- Policy BGL1
 - Policy BGL3
 - Policy BGL4
 - Policy BGL8
 - Policy BGL9
- 7.3 No mitigation measures have been included within the screening of the policies of the NDP. Policies of the Core strategy and the NDP will form part of the development plan. A key requirement of the Core Strategy is to meet the Water Framework Directive.
- 7.4 Legal opinion following the Sweetman case has indicated that in areas where there is adequate sewerage treatment works capacity and where Policy SD4 would apply to developments, then no likely significant effect could be concluded with regards to the NDP and there is no requirement for NDPs to include additional mitigation.
- 7.5 This review and rescreening have been found to be unlikely to result in significant effects on the River Wye SAC, the Wye Valley Woodlands SAC and Forest of Dean Bat Sites SAC. It is therefore concluded that the modifications made have not resulted in any policy changes that would mean that the **Linton NDP would not have a likely significant effect on the aforementioned three European Sites.**

Post examination modified Garway NDP

- 7.6 The plan was independently examined during summer 2020 and as a result some minor modifications that did not change the meaning or context of the policy were made.
- 7.7 The policies which have been subject to minor modifications during the examination are:
- Policy BGL1 (deleted)
 - Policy BGL3
 - Policy BGL4
 - Policy BGL6

- 7.8 There were some policies and objectives which received more substantial changes during the examination and therefore required rescreening are:
- Policy BGL2 (now BGL1)
 - Policy BGL6 (now BGL5)
- 7.9 Wording changes were made to the objectives however these did not alter the outcome of the objective and do not require rescreening. Wording changes were also made to Section 8 and Section 9, again these did not alter the meaning of the paragraphs and also did not require rescreening
- 7.10 This review and rescreening have been found to be unlikely to result in significant effects on the River Wye SAC and the Wye Valley Woodlands SAC Wye Valley and Forest of Dean Bat Sites SAC. It is therefore concluded that the modifications made have not resulted in any policy changes that would mean that the **Linton NDP would not have a likely significant effect on the aforementioned three European Sites.**

8 Identification of other plans and projects which may have ‘in-combination’ effects

- 8.1 There are a number of potentially relevant plans and projects which may result in in-combination effects with the Core Strategy across Herefordshire, these plans have been reviewed and can be found in Appendix 2 of the publication of the Herefordshire Local Plan Core Strategy Habitats Regulations Assessment (Oct 2015).
- 8.2 It is seen that as this NDP does not go over and beyond the requirements set out in the Core Strategy.
- 8.3 Adjacent neighbourhood plans Upton Bishop (at draft stage), Weston under Penyard (adopted), Lea (adopted), Aston Ingham (at draft stage). These plans have not gone over and beyond the requirements set out within the Core Strategy for their area.
- 8.4 The HRA for the Core Strategy also identifies that both the Water Cycle Study for Herefordshire, which indicates the potential for planned water abstraction requirements combined with pressures on European Sites from the Core Strategy policies, and the review work on the Nutrient Management Plan, have both been considered as part of the in-combination assessment.
- 8.5 It is unlikely that the Linton Plan will have any in-combination effects with any plans from neighbouring parish councils as the level of growth proposed is the same as that proposed for the Ross-on-Wye Housing Market Area in the Herefordshire Core Strategy.

9.0 Conclusion

- 9.1 With reference to sections 6 to 9 above, the NDP **will not have a likely significant effect on the River Wye SAC, the Wye Valley Woodland SAC Wye Valley and Forest of Dean Bat Sites SAC**

10.0 Next steps

- 10.1 This report will accompany the post examination version of the Linton NDP. The plan will move to referendum and, subject to a successful outcome, final adoption.

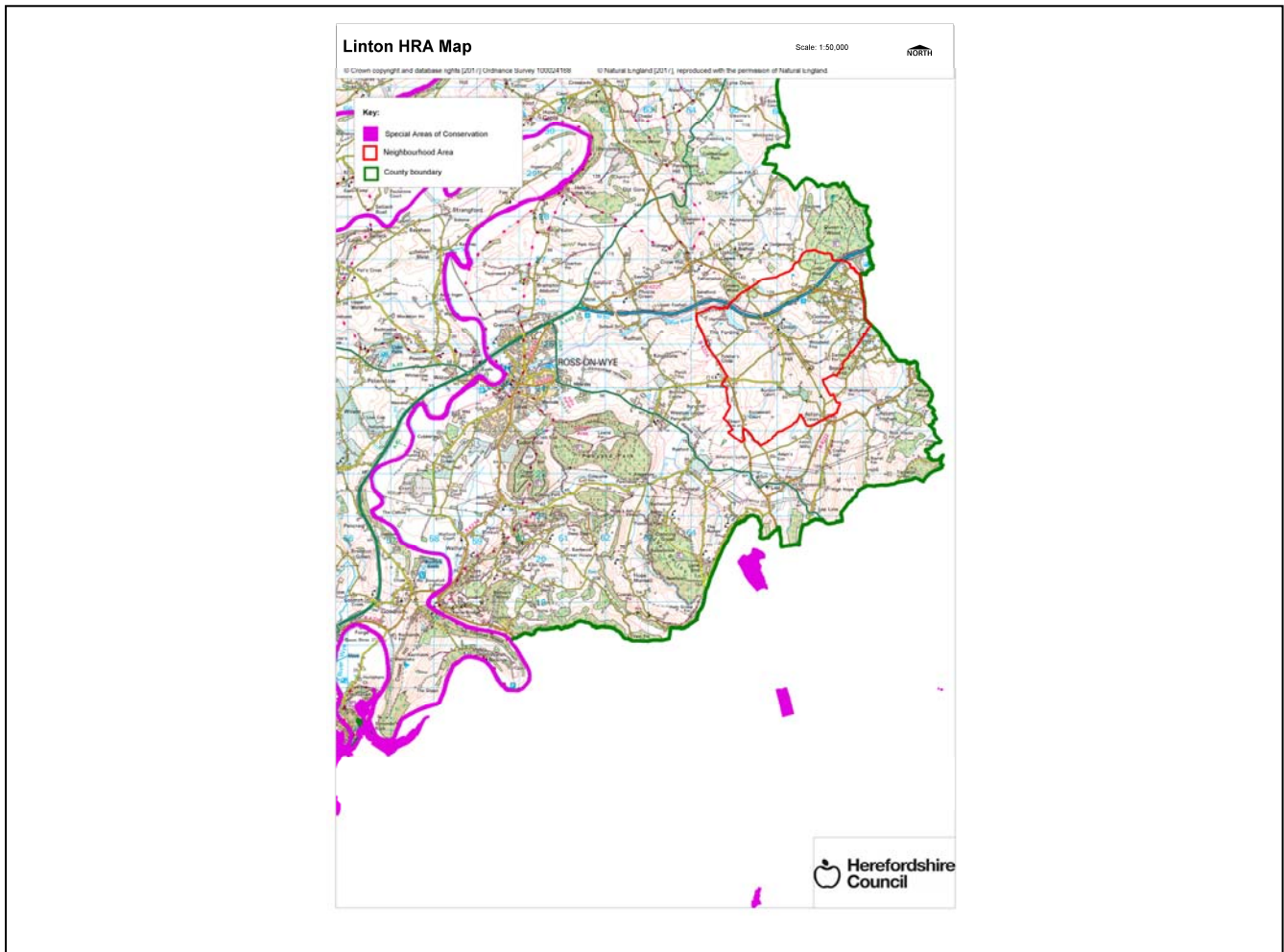
Introduction

Through continual engagement the outcomes of any required assessments will help to ensure that proposed developments will not lead to Likely Significant Effects upon a European site or cause adverse impacts upon other environmental assets, such as the built historic or local natural environment.

This is based on the sites individual features of integrity and their vulnerabilities, which could include distance criteria. Vulnerability data: Water quality is important to maintain the site feature. Parishes either side of the River Clun will be affected.
River Wye
Site Features: Water courses of plain to montane levels with the <i>Ranunculion fluitantis</i> and <i>Callitricho-Batrachion</i> vegetation. Transition mires and quaking bogs. White-clawed (or Atlantic Stream) crayfish <i>Austropotamobius pallipes</i> . Sea lamprey <i>Petromyzon marinus</i> . Brook lamprey <i>Lampetra planeri</i> . River lamprey <i>Lampetra fluviatilis</i> . Twaite shad <i>Alosa fallax</i> . Atlantic salmon <i>Salmo salar</i> . Bullhead <i>Cottus gobio</i> . Otter <i>Lutra lutra</i> . Allis shad <i>Alosa alosa</i>
Vulnerability data: Proximity: Developments should not be within 100m of the designated bank. Some developments beyond 100m may also have impacts based on proximity and these issues should be addressed where possible when developing NDP policy and choosing site allocations. Water Quality: Within the whole catchment of the River Wye, which includes the River Lugg, mains drainage issues with regards to water quality are being resolved through the Core Strategy / Local Plan and development of a Nutrient Management Plan. Welsh Water should be consulted to ensure that the proposed growth will be within the limit of their consents. Otters: "An otter will occupy a 'home range', which on fresh waters usually includes a stretch of river as well as associated tributary streams, ditches, ponds, lakes and woodland. The size of a home range depends largely on the availability of food and shelter, and the presence of neighbouring otters. On rivers, a male's home range may be up to 40km or more of watercourse and associated areas; females have smaller ranges (roughly half the size) and favour quieter locations for breeding, such as tributary streams. Otters without an established home range are known as 'transients'. They are mostly juveniles looking for a territory of their own, or adults that have been pushed out of their territories. Transient otters may use an area for a short while, but they will move on if conditions are not suitable or if they are driven away by resident otters. Transients will have been important in extending the range of otters, but they are very difficult to identify from field signs. Within a home range an otter may use many resting sites. These include above-ground shelters, such as stands of scrub or areas of rank grass, and underground 'holts' – for example, cavities under tree roots and dry drainage pipes."

Wye Valley and Forest of Dean Bat Sites

Site Features: Annex II species that are a primary reason for site selection: Lesser horseshoe bat *Rhinolophus hipposideros*. Greater horseshoe bat *Rhinolophus ferrumequinum*

Vulnerability data: Lesser Horseshoe bats are known to migrate between 5km and 10km between their summer and winter roosts. The Lesser Horseshoe Bat is vulnerable to disturbance; light pollution; and habitat loss. Check with the planning ecologist for other issues.

Greater Horseshoe bats are known to migrate between 20-30km between their summer and winter roosts.

NDPs closest to the European Site will need to consider:

Woodland habitat buffer.

Lesser Horseshoe Bat: Old buildings; woodland locations; sheltered valleys, extensive deciduous woods or dense scrub, close to roost sites. In areas of fragmented habitats, linear habitats such as hedgerows are important corridors. Vulnerable to loss or disturbance of both summer and winter roosts and removal of linear habitat.

Greater Horseshoe Bat: Large buildings, pasture, edge of mixed deciduous woodland and hedgerows. Mixed land-use especially south-facing slopes, favours beetles, moths and insects they feed on. During the winter they depend on caves, abandoned mines and other underground sites for undisturbed hibernation. A system/series of sites required. Vulnerable to loss of insect food supply, due to insecticide use, changing farming practices and loss of broad-leaved tree-cover and loss / disturbance of underground roosts sites.

Wye Valley Woodlands

Site Features: Annex I habitats that are a primary reason for site selection: Beech forests *Asperulo-Fagetum*, *Tilio-Acerion* forests of slopes, screes and ravines, *Taxus baccata* woods of the British Isles. Annex II species present as a qualifying feature, but not a primary reason for site selection: Lesser horseshoe bat *Rhinolophus hipposideros*, 51-100 residents

Vulnerability data: Lesser Horseshoe bats are known to migrate between 5km and 10km between their summer and winter roosts. The Lesser Horseshoe Bat is vulnerable to disturbance; light pollution; and habitat loss. Check with the planning ecologist for other issues. NDPs closest to the European Site will need to consider: Woodland habitat buffer. Lesser Horseshoe Bat: Old buildings; woodland locations; sheltered valleys, extensive deciduous woods or dense scrub, close to roost sites. In areas of fragmented habitats, linear habitats such as hedgerows are important corridors. Vulnerable to loss or disturbance of both summer and winter roosts and removal of linear habitat.
