hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Adding a public bridleway which runs from Point A on the application map (OSGR SO 3264 2838), by the convergence of the C1203 (from C1205 to Monnow Farm) and the C1205 (Rhydunnog Lane to Powys Boundary), to Point A1 (OSGR SO 3346 2801), where the route joins Longtown Footpath 22.
- b) Upgrading the public footpath Longtown Footpath 22 from Point A1 (OSGR 3346 2801), to Point B (OSGR SO 3396 2749) at the termination of Upper House Farm Road (U74410) to a public bridleway.
- c) Upgrading the public footpath Longtown Footpath 14 from Point B (OSGR SO 3396 2749), the termination of Upper House Farm Road (U74410), to Point B1 (OSGR SO 3430 2830), to a public bridleway.
- d) Adding a public bridleway from Point B1 (OSGR 3430 2830), to Point B2 (OSGR SO 3438 2867).
- e) Upgrading the public footpath Longtown Footpath 14 from Point B2 (OSGR 3438 2867) to Point C (OSGR SO 3424 2938) the C1213 (from River Monnow to Shepherds Hill) to a public bridleway.
