1.1 What is the proposal?

This project will review the pathways and commissioned services offered for individuals with a learning disability and/or complex needs who are under the age of 65, and develop new ways of meeting these individuals' needs while promoting better outcomes, independence, choice and control, and ensuring value for money.

The project will also review the costing model for supported living providers to ensure individual's outcomes continue to be met within the Council's financial envelope. Savings of £1.5million are expected through modernising commissioning, assessment and services delivery for clients with learning disability and complex needs.

3.2 Summary of engagement or consultation undertaken

Engagement will take place with social workers and service users as part of their individual reviews. This will allow social workers to have a conversation with service users on alternative ways to meet their needs; such as using technologies and a virtual offer. It should be noted that there may still be a need for a reduced building based provision and that 'one size will not fit all' due to the changing and complex needs of this service user group.

Engagement will also take place with providers to identify alternative ways to offer services and with the Council's Digital Programme and Talk Community and other relevant stakeholders.

3.3 Summary of relevant findings

The project will work to ensure it meets the Council's Carbon Management Plan to become carbon neutrality by 2030/31. This will be achieved through behavioural change, efficiencies and the use of technology. These principles are fundamental in redesigning the service offer and reducing our carbon footprint.

Care services are necessary for sustaining and improving wellbeing, yet they have an environmental footprint that contributes to environment-related threats to health. Bearing this in mind, improvements can be made by increasing efficiency at a delivery level, through the use of energy-efficient technologies and offering services that don't require the need for transportation and the use of buildings to meet the needs of individuals. The current service model for learning disabilities and complex needs is heavily dependent on delivery services in a building and requires service users to commute mostly using some form of transportation to the building in order to receive a service. To help reduce the carbon footprint and carbon emission it is imperative that through this project the service consider alternative ways to transform and redesign the

learning disabilities and complex needs offer for services users that still ensures they continue to meet their desired outcomes and live independently.
