Aston Ingham Village Hall.

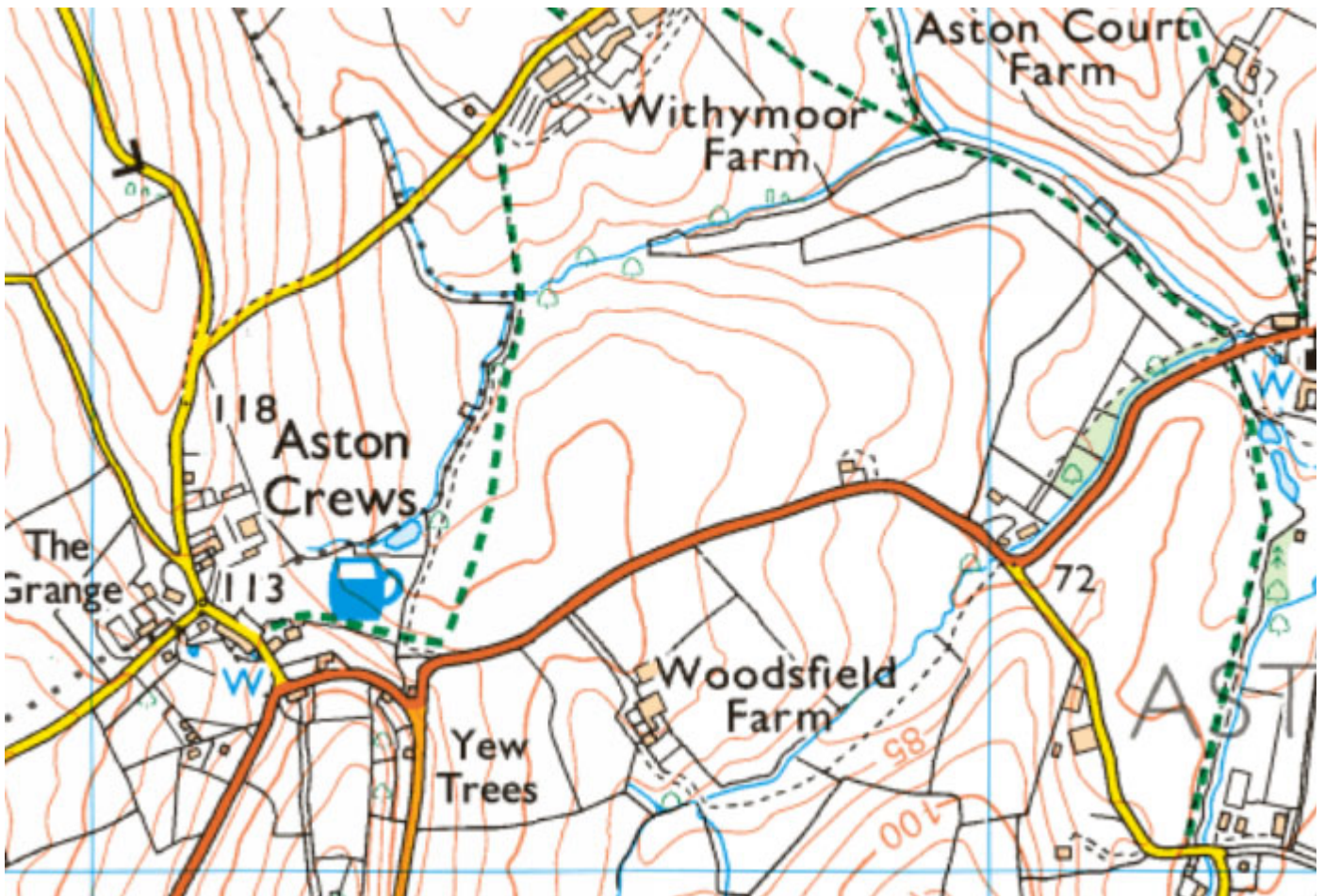
St John the Baptish Church.
