Herefordshire Council do not issue fixed penalty charge notices for driving violations other than parking.

32. What was the loss of income from the parking spaces in Gaol Street carpark whilst the plant tubs are being stored during the Mayfair 2023?

The loss of income on the Gaol Street car park attributed to the planters and fork lift truck is estimated to be £1,349. In reality the actual loss of income to the council is minimal as any motorists unable to find a parking space would likely to be displaced to another city centre car park, albeit some may be displaced to a privately run car park.

33. How many fines (FPNs) for car parking were issued in your council area in 2021/2022?

The council does not issue FPN's for car parking offense, therefore nil. If you are referring to Penalty Charge Notices (PCN's) the council issued 19,997 PCN's in 2021/22.

34. I would like to know how much money, if any has been recovered using bailiffs (debt collection agencies) in 2021, 2022 and 2023, broken down to the amount by year, for the following debts:

There have been 21,995 PCN's issued in 2022/23. 4,581 of these were appealed.

Year 2023 - currently Herefordshire Council have 45 active permits for this area. The service area cannot tell what permits are visitors / residential as the system will only provide how many active permits are "live".

There are no actual marked individual spaces - the bays are unmarked and in essence continuous bays so the service area cannot state how many vehicles can park within these bays, this will depend on the size of vehicle etc.

As such we consider this information to be exempt under Section 21 of the Freedom of Information Act 2000 because it is reasonably accessible to you via other means. Please take this letter as a refusal notice under S17 of the Act.

With regards to Q3 and fees for the previous years, please find attached our Notice of Variation of Car Park Charges.

#### **Notice of Variation of Car Park Charges**

64. The total number of parking fines (on- street and off-street) issued in the area covered by your council from 01/01/2023 - 31/12/2023 (or latest period as close to current date as possible). The type of parking offence each fine was, including: The number of fixed penalty notice fines, the number of penalty charge notice fines and the number of other parking fines.

We can confirm that between 01/01/2023 and 31/12/2023 23,164 PCN's (Penalty Charge Notices) were issued.

13,883 were on - street

9,281 were off - street

We do not issue any other kind of parking fine.

65. Could you please give me the recent data for how much money is made from each of your car parks in Herefordshire? Providing the data in an Excel spreadsheet, can you state how much was money was generated from each of your car parks in Hereford, Leominster, Bromyard, Ledbury, Ross-on-Wye and Kington, with each individual car park listed. Can this be collated for the year 2023, or if not the last financial year please? UPDATE: Please can you provide information regarding both the income and profit generated?

This information is not held in a form that would enable it to be located, retrieved and extracted within the Appropriate Time Limit which equates to 18 hours as defined by the Freedom of Information and Data Protection (Appropriate Limits and Fees) Regulations 2004.

For the following 4 points: Number of vehicles clamped; Number of vehicles towed / removed; Council net revenue (after paying contractors) from those paying to remove clamps; and Council net revenue (after paying contractors) from those paying towing fines, our electronic reporting systems are unable to run a report for this information. To ascertain the data requested, officers would need to manually check individual files for this information. An initial search has shown that between 1500 - 2000 files would need to be checked for this information, and it is estimated that it would take 5 minutes to check each file. Once the details had been identified this would need to be noted and once all files had been checked in this way, the total figures requested could be calculated.

This would at a conservative estimate take at least 125 hours to complete. Where the Limit is exceeded Public Authorities are not obliged to supply the information requested by virtue of S12 of the Act. Please take this letter as a refusal notice under S17 of the Act.

However, within the 18 hour limit, we can provide answers for the remaining 3 points: Total number of parking enforcement notices issued; Number of parking tickets (Penalty Charge Notice (PCN) or an Excess Charge Notice (ECN)) issued; and Council net revenue (after paying contractors) from parking fines (Penalty Charge Notice (PCN) or an Excess Charge Notice (ECN)), as requested. Please advise us if this is something you require.
