8.14 Accessibility standards for the provision for children and young people (play spaces) are shown in **Table 8.4**.


Table 8.4: Accessibility standards for hierarchies for play spaces

Hierarchy	Size threshold	Catchment areas
Neighbourhood	0.1ha	1000m
Local	0.04ha	200m
Doorstep	0.01ha	100m

8.15 **Figure 8.14** to **Figure 8.16** show the accessibility to play spaces across Herefordshire. These are also shown for the major settlements in **Figure 8.17** to **Figure 8.34**.

8.16 Overall, access to neighbourhood play spaces is good within the main settlements. Access to local and doorstep provision is generally poorer. Bromyard has limited access to play spaces.

Figure 8.14: Access to neighbourhood play provision





Figure 8.16: Access to doorstep play provision



Figure 8.17: Access to neighbourhood play provision in Hereford





Figure 8.19: Access to doorstep play provision in Hereford



Figure 8.20: Access to neighbourhood play provision in Bromyard





Figure 8.22: Access to doorstep play provision in Bromyard






