

NOTICE OF MAKING

HEREFORDSHIRE COUNCIL (BELMONT COURT, BELMONT AVENUE & SPRINGFIELD AVENUE, HEREFORD) (PROHIBITION OF WAITING AT ANY TIME) ORDER 2023

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Sections 1, 2 & 3 of Part 1 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, and of all other enabling powers make the above Order, the general effect of which will be to introduce:

No Waiting at Any Time (Double Yellow Line) restrictions on the following lengths of road:

Belmont Avenue (Southern Side): From its junction with A465 Belmont Road to its junction with Belmont Court. From its junction with Belmont Court for a distance of 14m in a westerly direction. From its junction with Springfield Avenue for a distance of 7m in an easterly direction. From its junction with Springfield Avenue for a distance of 14m in a westerly direction.

Belmont Avenue (Northern Side): From its junction with A465 Belmont Road for a distance of 72m in a north-westerly direction.

Belmont Court (Western Side): From its junction with Belmont Avenue for a distance of 70m in a southerly direction.

Belmont Court (Eastern Side): From its junction with Belmont Avenue for a distance of 10m in a southerly direction.

Springfield Avenue (Western Side): From its junction with Belmont Avenue for a distance of 15m in a southerly direction.

Springfield Avenue (Eastern Side): From its junction with Belmont Avenue for a distance of 14m in a southerly direction.

This Order will come into effect on **16th October 2023**.

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with that person may, within six weeks from the date the Order was made, apply for the purpose to the High Court.

Any representations received by the Council may be imparted to third parties. We will keep your data for up to 7 years. Your information may be shared with other Balfour Beatty teams within Herefordshire and Herefordshire Council in order to provide you with the service. Individuals have a number of rights under data protection law, including the right to request their information.
