## NOTICE OF MAKING HEREFORDSHIRE COUNCIL (VARIOUS TRAFFIC MOVEMENTS) (CONSOLIDATION) ORDER 2022 (VARIATION) ORDER No.1 2023 (C1011, KINSHAM AND C1001, BUCKTON)

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 has made the above-named order the effect of which will be to vary the Herefordshire Council (Various Traffic Movements) (Consolidation) Order 2022 (the 2022 Order) so that:

The existing 10 tonne structural weight limit on C1001 at Buckton and the existing 5 tonne structural weight limit on C1011 at Kinsham are proposed to be revoked in full. The bridges have recently been strengthened. Therefore, the weight restrictions are no longer required. Unsuitable for HGV Signage will be implemented to deal with traffic taking unsuitable routes, despite the strengthening of the bridges.

This Order shall come into operation on Monday 15<sup>th</sup> January 2024.
