

NOTICE OF MAKING

HEREFORDSHIRE COUNCIL (MORTIMER ROAD, PERSEVERANCE ROAD & A49 NEWTOWN ROAD, HEREFORD) (PROHIBITION OF WAITING AT ANY TIME) ORDER 2024

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Sections 1, 2 and 3 of Part 1 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, and of all other enabling powers make the above Order, the general effect of which will be to introduce: **No Waiting at Any Time (Double Yellow Line) restrictions on the following lengths of road:** **Perseverance Road (Northern Side)** From a point 7m east of its junction with Holmer Service Road for a distance of 30m in an easterly direction. From its junction with Mortimer Road for a distance of 10m in a north-westerly direction. **Perseverance Road (Southern Side)** From a point 7m east of its junction with Holmer Service Road for a distance of 31m in an easterly direction. From its junction with Mortimer Road for a distance of 11m in a north-westerly direction. **Mortimer Road (Western Side)** From its junction with **Perseverance Road** for a distance of 10m in a north-easterly direction. From its junction with **Perseverance Road** for a distance of 9m in a south-westerly direction. From its junction with A49 Newtown Road for a distance of 32m in a north-easterly direction. **Mortimer Road (Eastern Side)** From its junction with A49 Newtown Road for a distance of 30m in a north-easterly direction. **A49 Newtown Road (Northern Side)** From its junction with Mortimer Road for a distance of 3m in a south-easterly direction. From its junction with Mortimer Road for a distance of 11m in a north-westerly direction.

This Order will come into effect on 10th June 2024.

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with that person may, within six weeks from the date the Order was made, apply for the purpose to the High Court.

Any representations received by the Council may be imparted to third parties. We will keep your data for up to 7 years. Your information may be shared with other Balfour Beatty teams within Herefordshire and Herefordshire Council in order to provide you with the service. Individuals have a number of rights under data protection law, including the right to request their information.
