## Joint All Ages Autism Strategy - Glen Crosier, Jack Caine

The final version of the strategy is going through the design process. Glen is in the process of arranging the official approval steps and implementation stages that the strategy has to go through to get to the 28<sup>th</sup> of March Cabinet meeting to be indorsed and approved.

The ICB (Integrated Care Board) will have a similar sign off process for the strategy. The strategy has to be approved by both Herefordshire's and Worcestershire's Cabinets, both counties Health and Wellbeing Boards, the ICB's Autism and Learning Disability Partnership Board for approval and the Mental Health Collaborative for information purposes.

Once the strategy is approved a steering group will oversee the implementation of all strands of the strategy. The plan of how this will operate is still to be formalised. The health strand of this will report to the ICB Learning Disability and Autism Programme Board which meets quarterly.

**Action 1** - Valerie asked Glen to check that the changes requested to the Autism Strategy at the strategy sign off meeting on the 28<sup>th</sup> of November have been made.

The Autism Champion Bernadette Louise will be doing a presentation on the Joint All Ages Autism Strategy for Worcestershire County Council as part of the governance process in late March. Valerie queried whether a similar presentation will be required as part of the Herefordshire governance process.

**Action 2 -** Glen will have a discussion with Haley Doyle and other colleagues about this and get back to Valerie.

## Joint Children's Autism and ADHD Diagnosis Pathway - Anna Swift

A key part of the health strand of the Joint All Ages Autism Strategy is the re-organisation and recommissioning of the Children's Diagnostic Pathway. The plan is to have a simpler joint children's diagnostic pathway across both counties that covers autism and ADHD diagnosis.

Anna Swift who has led work around the health strand is planning on putting together groups around the autism assessment and pathway; a diagnostic group; and, a pre- and post-support group.

#### Carers Strategy - John Gorman

The Herefordshire only strategy is currently in draft. It will go through the governance process between May and June 2024.

Once the strategy is approved a Carer's Partnership Board will be set up.

The Carers Strategy encompasses a wide range of people with different needs, therefore, a decision was made to not show favouritism to any particular cohort. John Burgess is currently working on an over-arching statement that will cover a wide range of issues carers and those receiving care face in Herefordshire.

# Oliver McGowan Mandatory Training - Debbie Hobbs

Valerie read out an update from Josh Swinson-Davis as he was unable to attend our meeting.

Debbie highlighted that the governance has changed around experts by experience which means that parents of autistic children or young adults can now become training facilitators.

The code of practice has also been updated with new frameworks in place. Tier 1 and Tier 2 training was been re-written.

The Police won't be invited to do the Oliver McGowan Mandatory Training. However, they will be invited to complete the National Autism Trainer Award with the Anna Freud Foundation, which focuses more on the legislation side.

The minimum age to deliver the training as an expert by experience is 19.

It is advised that interested parties in doing the training book up through ICB Academy quickly. Lots of interest in the training is coming from out of county including Norfolk. Debbie doing training not just in Herefordshire and Worcestershire but also Gloucestershire. There are no training spaces for Tier 2 until the end of May.

#### ICB - Updates - Jack Caine

# a) Reasonable Adjustments Digital Flag Project

This project which is in the NHS long term plan is about working with health and social care providers to identify and flag people who have a learning disability and/or autism. Then provide these individuals with the reasonable adjustments that they need.

With different health providers and NHS Trusts using different systems this project is a logistically challenging project. The aim is for this project to start in April.

## b) Annual Health Checks

A National roll out of annual health checks for autistic individuals in underway. In terms of uptake for annual health checks for people with learning disabilities it is around 60%. We are on track to match uptake figures from last year that are some of the best in the country.

#### c) Sensory Friendly Environments

The project is approaching the end of its second year. Reviews of the changes GP Surgeries have made is currently taking place. Hereford Medical Group (HMG) and Ledbury Surgery have been planned.

Valerie highlighted issues with Hereford Medical Group and the slowness of making the agreed improvements. Valerie and Jack will be revisiting them in February to see if they have finally made the agreed changes.

For Herefordshire and Worcestershire thirty-three reports have been logged. Confirmed introductory meetings have been scheduled with Whiteacres Surgery, Kington Surgery and Worcestershire Royal Hospital. Meetings are currently in the process of being confirmed with Davenal House Surgery, New Road Surgery, Haresfield Surgery, Churchfields Surgery and Nunwell Surgery.

Meetings have taken place with Lancashire and Cumbria ICB regarding the project and there are plans to meet with Warwickshire Council.

#### **Feedback from Partner Organisations**

Hereford Disability United - Silvia Nicholls

Mental Health Event - 24<sup>th</sup> of January, Kindle Centre, Hereford. The event will relate to children and people below 30 with mental health issues and the services that are available for them. Speakers from organisations such as Herefordshire Young Carers Club, Mind, CLD Trust, Marches Counselling Service, Brightfire CIC and Travelers Times will be there.

#### Local NAS - Debbie Hobbs

Debbie informed the group that the branch is no longer working from Fred Bulmer's Centre. Five new volunteers are currently being trained. More families and young people are coming through without an autism diagnosis, exacerbated by the growing waiting list for the diagnosis pathway.

For Autism Acceptance week the local NAS is running an autism spectrum walk.

#### Parent Carer Voice - Debbie Hobbs

Debbie has met three families that have had their autism diagnosis being unaccepted by the authorities due to the individuals having a private diagnosis assessment that were not NICE compliant.

## • Cart Shed - Alex Fitzpatrick

Is looking into securing funding to enable it to offer its Being Autistic programme to a younger age group.

#### Hereford Make - James Baker

Hopes to do blacksmithing with the Cart Shed and other organisations such as schools in the future by using portable forges.

Hereford Make has also secured Awards for All funding.

Hereford Make was also getting individuals including students partaking in their service that have unmet housing and social care needs and may lack capacity to seek these assessments. James would like to find out if a member of ART (Advice Referral Team) could visit Hereford Make semi regularly to help these individuals get their needs assessed.

Action 4 - John will find an ART contact for James to liaise with.

**Action 5** - James and Helen will also have a conversation about who would be the best person to help with the individuals' accommodation needs.
