WILDLIFE AND COUNTRYSIDE ACT 1981 DEFINITIVE MAP AND STATEMENT FOR THE COUNTY OF HEREFORDSHIRE

HEREFORDSHIRE COUNCIL (UPGRADE OF FOOTPATH DD1 (PART) TO A RESTRICTED BYWAY, ADDITION OF RESTRICTED BYWAY DD21 IN THE PARISH OF DINEDOR AND ADDITION OF RESTRICTED BYWAY LOB12 IN THE PARISH OF LOWER BULLINGHAM) MODIFICATION ORDER 2024

This order is made by the County of Herefordshire District Council (known as "Herefordshire Council") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to Herefordshire Council that the Definitive Map and Statement for the County of Herefordshire requires modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) of the Act, namely the discovery of evidence which shows that a right of way subsists or is reasonably alleged to subsist and 53(3)(c)(ii), namely that there is a public right of way over land shown in the map and statement as a highway of a particular description which ought to be there shown as a highway of a different description.

Herefordshire Council hereby orders that:

- 1. For the purposes of this order the relevant date is 4th June 2024.
- 2. The Definitive Map and Statement for the County of Herefordshire shall be modified as described in Part I and Part II of the Schedule hereto and shown on the plan attached to this order.
- This order shall take effect on the date it is confirmed and may be cited as Herefordshire Council (Upgrade of Footpath DD1 (Part) to a Restricted Byway, Addition of Restricted Byway DD21 in the Parish of Dinedor and Addition of Restricted Byway LOB12 in the Parish of Lower Bullingham) Modification Order 2024.

Description of public right of way to be upgraded

Footpath A-B

Commences at the County Road U72010 at OS Grid Reference SO 5349 3701 (point A on the order plan) and follows a generally east north-easterly direction for approximately 55 metres to OS Grid Reference SO 5354 3703 (point B on the order plan). (To be known as Restricted Byway DD21 Dinedor).

Width – 4.0 metres, as measured from the Ordnance Survey circa 1904 Map

Description of path or way to be added

Restricted Byway B-C-D

Commences at OS Grid Reference SO 5354 3703 (point B on the order plan) and follows a generally westerly then north-westerly direction for approximately 328 metres to OS Grid Reference SO 5323 3707 (point C on the order plan). It continues in a generally north north-westerly and then west north-westerly direction for approximately 304 metres to the parish boundary with Lower Bullingham at OS Grid Reference SO 5303 3725 (point D on the order plan). (To be known as Restricted Byway DD21 Dinedor).

Width - between 3.0 and 7.0 metres, as measured from the Ordnance Survey circa 1904 Map

Restricted Byway D-E

Commences at the parish boundary with Dinedor at OS Grid Reference SO 5303 3725 (point D on the order plan) and follows a generally westerly direction for approximately 116 metres to the County road U72016 at OS Grid Reference SO 5291 3726 (point E on the order plan). (To be known as Restricted Byway LOB12 Lower Bullingham).

Width – between 3.0 and 4.0 metres, as measured from the Ordnance Survey circa 1904 map

Restricted Byway DD21

Commences at the County Road U72010 at OS Grid Reference SO 5349 3701 and follows a generally east north-easterly direction for approximately 55 metres to OS Grid Reference SO 5354 3703 then in a generally westerly then north-westerly direction for approximately 328 metres to OS Grid Reference SO 5323 3707. It continues in a generally north north-westerly and then west north-westerly direction for approximately 304 metres to the parish boundary with Lower Bullingham at OS Grid Reference SO 5303 3725.

Width - between 3.0 and 7.0 metres, as measured from the Ordnance Survey circa 1904 Map

Restricted Byway LOB12

Commences at the parish boundary with Dinedor at OS Grid Reference SO 5303 3725 and follows a generally westerly direction for approximately 116 metres to the County road U72016 at OS Grid Reference SO 5291 3726.

Width – between 3.0 and 4.0 metres, as measured from the Ordnance Survey circa 1904 map

Footpath DD1

From Restricted Byway DD21, 420 metres NNE of Dinedor Church, at OS Grid Reference SO 5354 3703 to C.rd at RLY. BR. at SE corner of Rotherwas Park.
