#### 2. Minutes from last meeting

## 4a. Engagement Plan

It was discussed that farmer, landowners and land managers could have their own warm-up event. It was decided that the DEFRA video should be used within the webinar, for the background.

Action: RP to share frequently asked questions for other local authorities

Action: AA to explore creating a SharePoint

It was confirmed that habitats, species and spatial mapping will be blended together into one event covering all aspects and biological recorders, specialist and NGOs would be engaged with.

Action: AA to update the Gantt chart to reflect the agreed engagement plan.
