1. Welcome and Apologies:

2. Minutes from last meeting

There were no outstanding actions arising from previous minutes.

3. Gantt Chart Progress

AA gave a brief update on progress regarding the project planning in relation to design work, strategy, mapping and species longlisting.

Detailed discussion included the species longlist being longer than expected and the current inclusion of multiple local BAP species which included those species known to be priority and species where more research is required.

RP reported that other responsible authorities had a range of 500-1200 species included in the longlist.

Action: RP to clarify whether the guidance allows or encourages removal of species where more research is required

Action: RP to check with Jack Bonnick if there is a way to shorten the longlisting prior to applying shortlisting criteria

Action: AA to circulate long list to DEFRA at the same time it goes to county recorders Action: AA to share the most recent version of the Gantt chart

4. SharePoint

AA gave update on SharePoint which has been agreed in principle but will take some time to establish

5. Engagement and Timelines

AA outlined the timeline for the awareness raising which included moving the welcome webinar to the 2^{nd} week of June and having a presence at the three counties show ($14^{th} - 16^{th}$ June). HD raised that CLA would be having a breakfast event on Friday
