## HEREFORDSHIRE COUNCIL (SPEED LIMIT) (CONSOLIDATION) ORDER 2022 (VARIATION) ORDER No.6 2023 (B4220, BOSBURY VILLAGE) (30MPH SPEED LIMIT EXTENSION & 40MPH SPEED LIMIT)

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 has made the above-named order the effect of which will be to vary the Herefordshire Council (Speed Limit) (Consolidation) Order 2022 (the 2022 Order) so that:

## A 30mph speed limit be introduced on the following road:

**B4220** – From a point 169 metres north-east of its junction with the C1173, to a point 337 metres north-east of its junction with the C1173. A distance of approximately 168 metres.

## A 40mph speed limit be introduced on the following road:

**B4220** – From a point 337 metres north-east of its junction with the C1173, to a point 48 metres of its junction with the C1165. A distance of approximately 605 metres.

This Order shall come into operation on Monday 3<sup>rd</sup> June 2024.

Any representations received by the Council may be imparted to third parties. We will keep your data for up to 7 years.
