NOTICE OF PUBLIC PATH ORDER

HIGHWAYS ACT 1980 SECTION 119

**HEREFORDSHIRE COUNCIL
PUBLIC FOOTPATH LY6 (PART) LLANCILLO
PUBLIC PATH DIVERSION ORDER 2024**

The above order made on 14th November, 2024 under Section 119 of the Highways Act 1980 will divert that length of Footpath LY6 (Part) in the Parish of Llancillo which commences at OS Grid Reference SO 3759 2568 (point A on the order plan) and proceeds in an east north-easterly direction for approximately 43 metres to a field gate. It continues through a farm building and through the farmyard for approximately 127 metres to a field gate at OS Grid Reference SO 3773 2577 (point B on the order plan), then in a generally north easterly direction for approximately 119 metres to join footpath RW5 at OS Grid Reference SO 3780 2586 (point C on the order plan).

The total length of the existing said footpath is approximately 289 metres.

An alternative footpath will be created, being 2 metres in width, which commences at OS Grid Reference SO 3759 2568 (point A on the order plan) and proceeds in a north north-easterly direction along the farm track for approximately 53 metres to a kissing gate at OS Grid Reference SO 3761 2573 (point D on the order plan). It continues in a generally westerly direction for approximately 12 metres, then in a generally northerly direction for approximately 200 metres to join footpath LY2 at OS Grid Reference SO 3757 2592 (point E on the order plan).

The total length of this public footpath will be approximately 265 metres.

If the order is sent to the Secretary of State, Department of Environment Food and Rural Affairs for confirmation, any representations or objections which have not been withdrawn will be sent with the order.
