

## **NOTICE OF MAKING**

### **HEREFORDSHIRE COUNCIL (VARIOUS ROADS, EIGN HILL WARD, HEREFORD) (PROHIBITION OF WAITING AT ANY TIME) ORDER 2024**

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Sections 1, 2 and 3 of Part I and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, and of all other enabling powers make the above Order, the general effect of which will be to introduce No Waiting at Any Time Restrictions on various roads in the Eign Hill Ward of Hereford. These include Old Eign Hill, Vineyard Road, Hafod Road, Brookside, Lichfield Avenue, Sedgfield Road, Dymond Close, Chartwell Road, Bladon Crescent, Blenheim Close, Bodenham Road, Ledbury Road, Quarry Road & the Ledbury Road Service Roads.

This Order will come into effect on **2<sup>nd</sup> December 2024**.

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with that person may, within six weeks from the date the Order was made, apply for the purpose to the High Court.

*Any representations received by the Council may be imparted to third parties. We will keep your data for up to 7 years. Your information may be shared with other Balfour Beatty teams within Herefordshire and Herefordshire Council in order to provide you with the service.
