

**HEREFORDSHIRE COUNCIL
(SPEED LIMIT) (CONSOLIDATION) ORDER 2022
(VARIATION) ORDER No.5 2023
(A449 AND C1289, MUCH MARCLE)
30MPH SPEED LIMIT AND 40MPH SPEED LIMIT**

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 has made the above-named order the effect of which will be to vary the Herefordshire Council (Speed Limit) (Consolidation) Order 2022 (the 2022 Order) so that:

A 30mph speed limit be introduced on the following road:

C1289 – From its junction with the B4024, to a point 296 metres south of its junction with the B4024. A distance of 296 metres.

A 40mph speed limit be introduced on the following road:

A449 – From a point 228 metres south-west of its junction with the C1294, to a point 77 metres north-east of the north-eastern property boundary of The Royal Oak Public House. A distance of 1,215 metres.

This Order shall come into operation on Monday 3rd June 2024.

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with that person may, within six weeks from the date the Order was made, apply for the purpose to the High Court.

Any representations received by the Council may be imparted to third parties. We will keep your data for up to 7 years. Your information may be shared with other Balfour Beatty teams within Herefordshire and Herefordshire Council in order to provide you with the service. Individuals have a number of rights under data protection law, including the right to request their information.
