

**HEREFORDSHIRE COUNCIL
(SPEED LIMIT) (CONSOLIDATION) ORDER 2022
(VARIATION) ORDER No.9 2023
(B4216 NEW STREET & A417 LEDBURY BYPASS)
(30MPH & 40MPH SPEED LIMITS)**

Notice is hereby given that the County of Herefordshire District Council, known as Herefordshire Council, in exercise of its enabling powers under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 has made the above-named order the effect of which will be to vary the Herefordshire Council (Speed Limit) (Consolidation) Order 2022 (the 2022 Order) so that:

No person shall drive a motor vehicle at a speed exceeding 30 miles per hour along the following lengths of road: New Street (B4216) - From its junction with A417 Ledbury Bypass for a distance of 46m in a northerly direction.

No person shall drive a motor vehicle at a speed exceeding 40 miles per hour along the following lengths of road: Ledbury Bypass (A417) - from its junction with New Street (B4216) for a distance of 88m in a north-westerly direction.

This Order shall come into operation on 10th June 2024.

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with that person may, within six weeks from the date the Order was made, apply for the purpose to the High Court.

Any representations received by the Council may be imparted to third parties. We will keep your data for up to 7 years. Your information may be shared with other Balfour Beatty teams within Herefordshire and Herefordshire Council in order to provide you with the service. Individuals have a number of rights under data protection law, including the right to request their information.
