

Section 4 Duty to Cooperate (DtC) 2024

Introduction

- 1.1 Strategic policy-making authorities are required to cooperate with each other, and other bodies, when preparing, or supporting the preparation of policies which address strategic matters. This includes those policies contained in local plans (including minerals and waste plans) and spatial development strategies. The National Planning Policy Framework (NPPF) 2024 confirms that local planning authorities and county councils (in two-tier areas) continue to be under a duty to cooperate with each other, and with other prescribed bodies, on strategic matters that cross administrative boundaries.
- 1.2 The Core Strategy was adopted in October 2015. Tche Council is now in the process of preparing a new local plan to cover the period up to 2041 and the following table illustrates how the Council has and intends to engage with various organisations, including the prescribed bodies. This will include consideration of the revised NPPF and new housing figures resulting from revisions to the Standard Method. This process is ongoing, and the Council as a Local Planning Authority will continue to engage constructively with strategic policy-making authorities and relevant bodies as the plan progresses towards submission.
- 1.3 A Minerals and Waste Local Plan (MWLP) has been prepared to guide mineral extraction and the management of waste in Herefordshire up to 2041 and beyond. The MWLP was adopted in March 2024 and replaces the saved minerals and waste policies of the Unitary Development Plan. A judicial review of the Herefordshire Minerals and Waste Local Plan and High Court Hearings were held in December 2024. Updates on this will be posted on the Minerals and Waste Local Plan (MWLP) webpages.
