NOTICE OF PUBLIC PATH ORDER

HIGHWAYS ACT 1980 SECTION 119

**HEREFORDSHIRE COUNCIL
PUBLIC FOOTPATH ZC22 (PART) LEOMINSTER
PUBLIC PATH DIVERSION ORDER 2025**

The above order made on 13th March, 2025 under Section 119 of the Highways Act 1980 will divert that length of Footpath ZC22 (Part) in the Parish of Leominster which commences at OS Grid Reference SO 4838 5854 (point A on the order plan) and proceeds in a north north-westerly direction across the supermarket car park for approximately 165 metres and rises up a steep bank to County road A44 at OS Grid Reference SO 4832 5869 (point B on the order plan). The total length of the existing said footpath is approximately 165 metres.

An alternative footpath will be created, being 2 metres in width, which commences at OS Grid Reference SO 4838 5854 (point A on the order plan) and proceeds in a north easterly direction along the verge for approximately 14 metres to OS Grid Reference SO 4839 5854 (point C on the order plan). It then turns in a generally north north-westerly direction around the frontage of the supermarket for approximately 133 metres to OS Grid Reference SO 4835 5866 (point D on the order plan) and continues in a north north-westerly direction across a pedestrian crossing point for approximately 37 metres and rises up a set of steps to County road A44 at OS Grid Reference SO 4833 5870 (point E on the order plan). The total length of this public footpath will be approximately 184 metres.

A copy of the order, the order plan and explanatory statement, have been placed and may be seen free of charge at Blueschool House, Blueschool Street, Hereford, HR1 2AN during normal opening hours. Copies are also available on the Council's website at www.herefordshire.gov.uk.
