Please note that granite cases placed behind memorial plaques will remain in position subject to the renewal of the memorial plaque lease. If the lease is not renewed, the memorial plaque and granite vase will be removed and disposed of within 12 months by Herefordshire Council unless collected by the applicant leaseholder.

If the granite vase is for a grave this will fall within the conditions of the purchase of the Exclusive Right of Burial of their lease.

Private Sale (for collection from Bereavement Services office only)

Size of vase is 6"x6"x6". Granite Vases take approximately 6 - 8 weeks.

Upon receipt of the granite vase it will be placed behind the relevant memorial as requested by the applicant and a letter will be sent to them advising them of its arrival.
