

STATUTORY DECLARATION

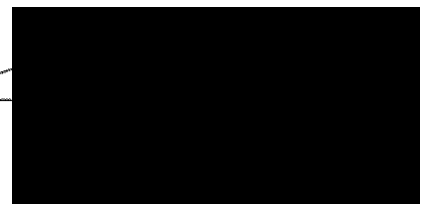
SECTION 31(6) OF THE HIGHWAYS ACT 1980

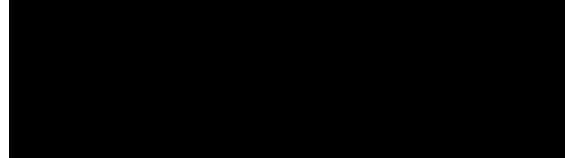
1. I am and have since the 16th September 1994 been owner of the land at Quarrel's Green Farm Abbeydore in the County of Hereford and Worcester more particularly delineated on the map accompanying this Declaration and thereon edged red
2. On the 28th day of November 1997 I deposited with Hereford and Worcester County Council, being the appropriate Council, a Statement accompanied by a map delineating my property by red edging which stated that the ways coloured purple on the said map and on the map accompanying this Declaration had been dedicated as footpaths and no other ways have been dedicated as highways over my property.
3. No additional ways have been dedicated on the land edged red on the map accompanying this Declaration since the Statement dated 24th November 1997 referred to in Number 2 above other than those footpaths marked in the appropriate colour on the map accompanying this Declaration and at the present time I have no intention of dedicating any more public rights of way over my property.

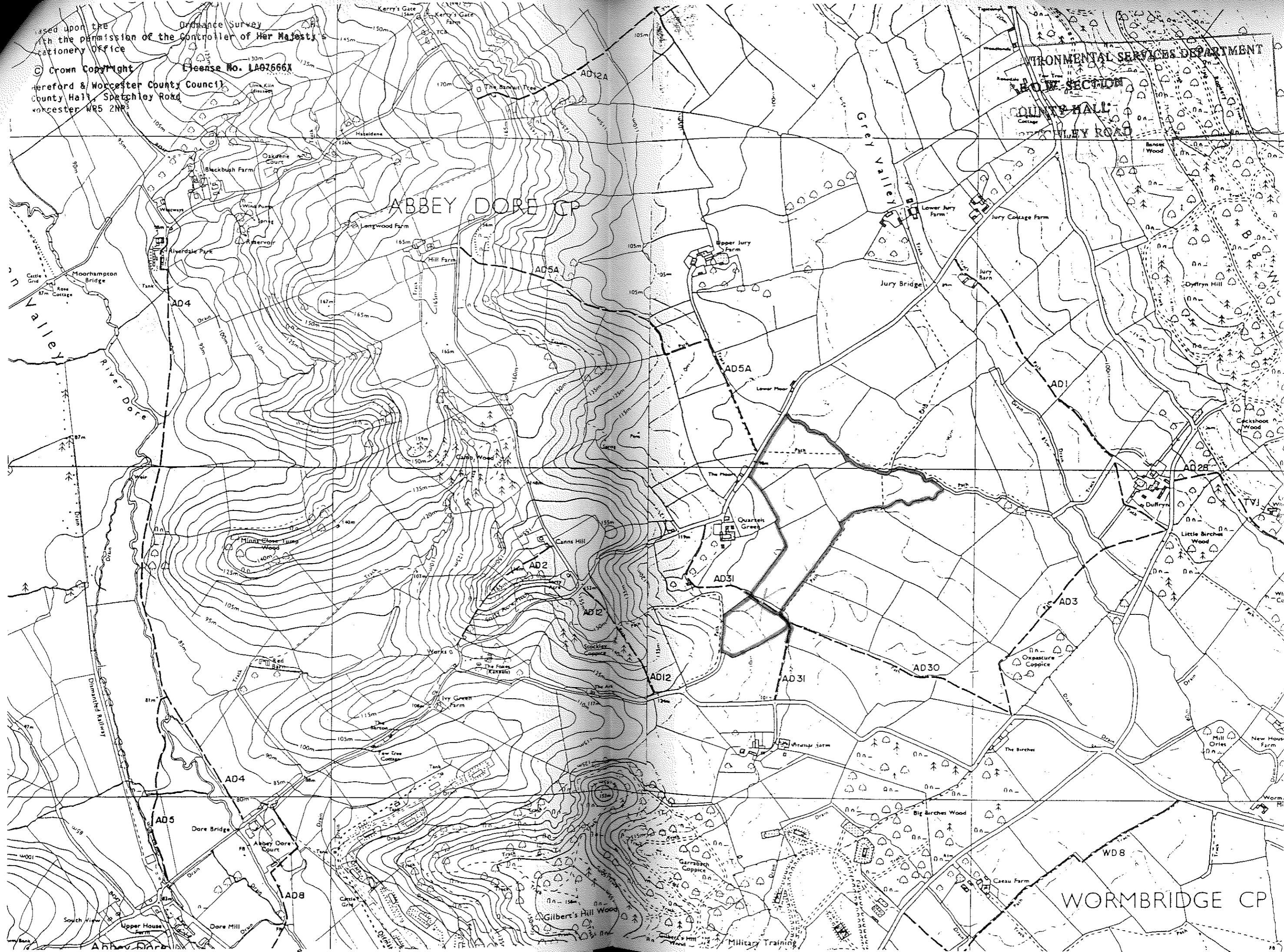

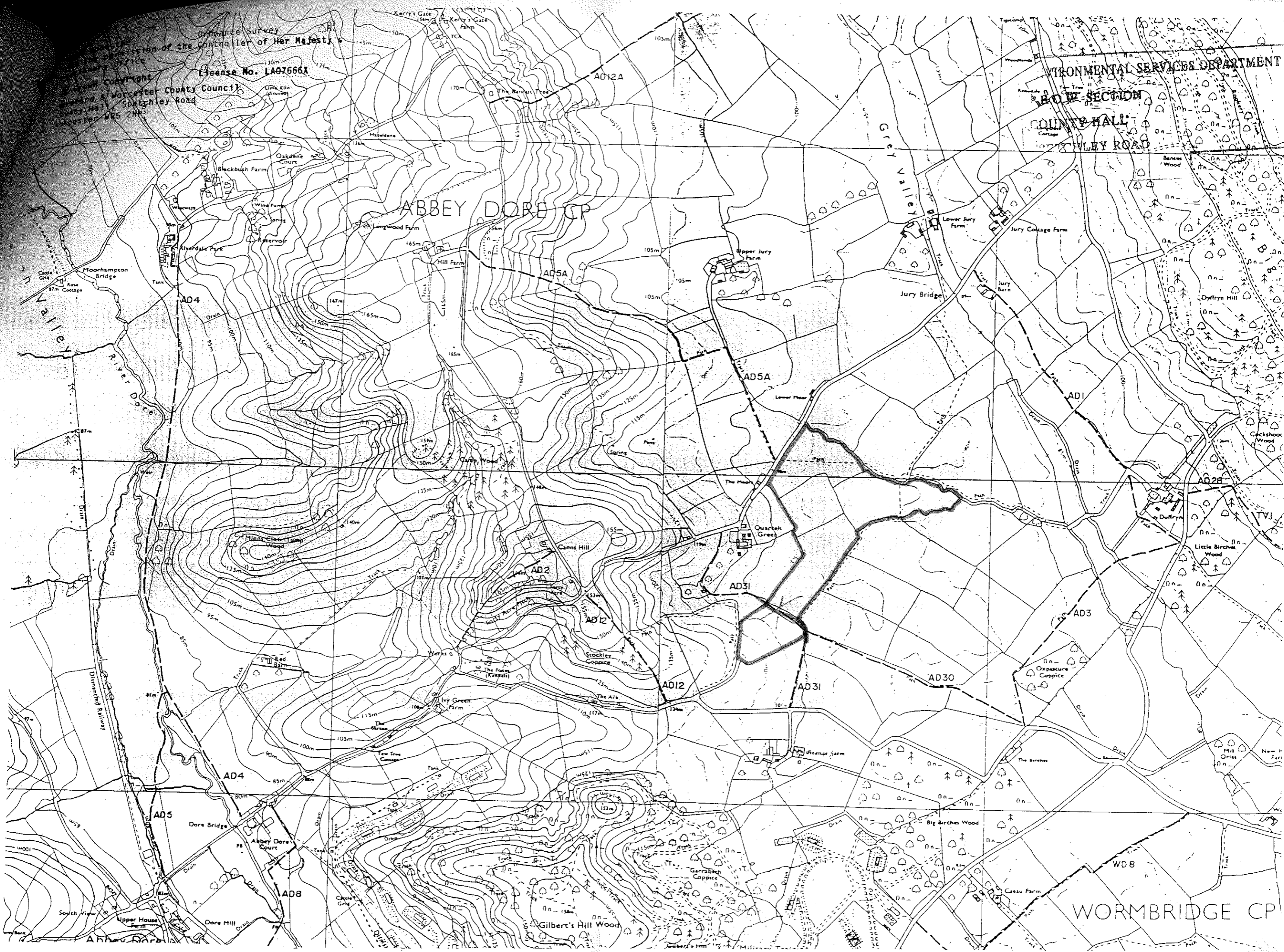
