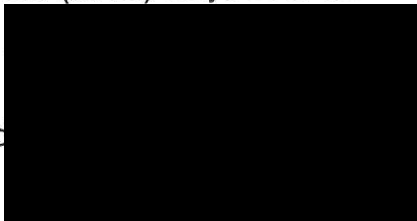

The ways coloured purple on the said map have been dedicated as footpaths (Nos; 1-3 enclosed).

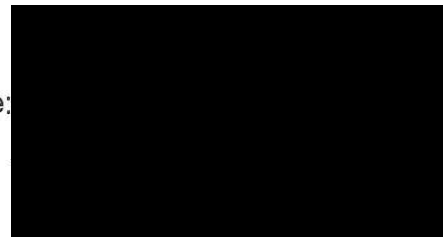
