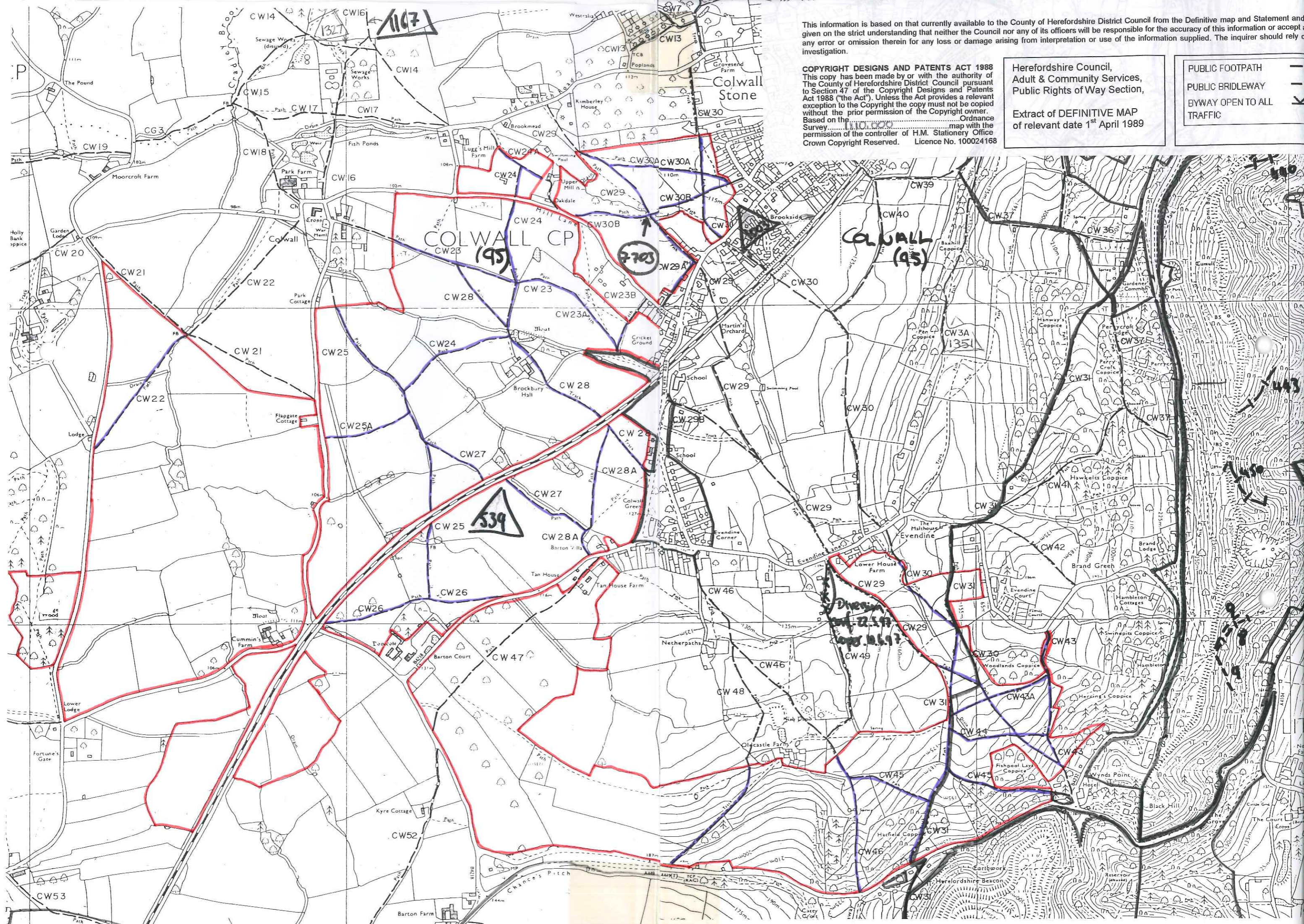

STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) ALLAN LLOYD DO SOLEMNLY AND SINCERELY DECLARE as follows:

- 1. I am and have been since (day, month, year) 1<sup>st</sup> JANUARY 1986 the owner of the land known as (name of farm, etc) BURTON COURT ESTATE more particularly delineated on the plan accompanying this declaration and thereon edged red.
