



STATUTORY DECLARATION

I, **John Williams**, DO SOLEMNLY AND SINCERELY DECLARE as follows:-

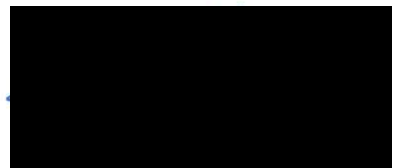
- 1 I am and have been since *January 1990* the owner of the land known as The Cats Back, Black Mountains more particularly delineated on the map accompanying this declaration and thereon edged red.
- 2 On the *5th* day of November 1997, I deposited with Hereford and Worcester County Council, being the appropriate Council, a statement accompanied by a map delineating my property by red edging which stated that the ways coloured green on the said map and on the map accompanying this declaration had been dedicated as bridleways and the ways coloured purple on the said map and on the map accompanying this declaration had been dedicated as footpaths no other ways had been dedicated as highways over my property.
- 3 No additional ways have been dedicated over the land edged red on the map accompanying this declaration since the statement dated *5th* day of November 1997 referred to in 2 above other than those bridleways and footpaths marked in the appropriate colour on the map accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.

AND I MAKE this solemn declaration on the *27th* day of November 1997 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.

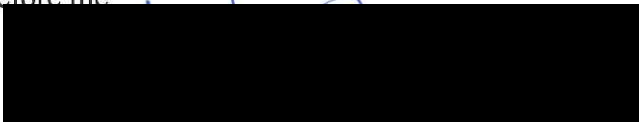

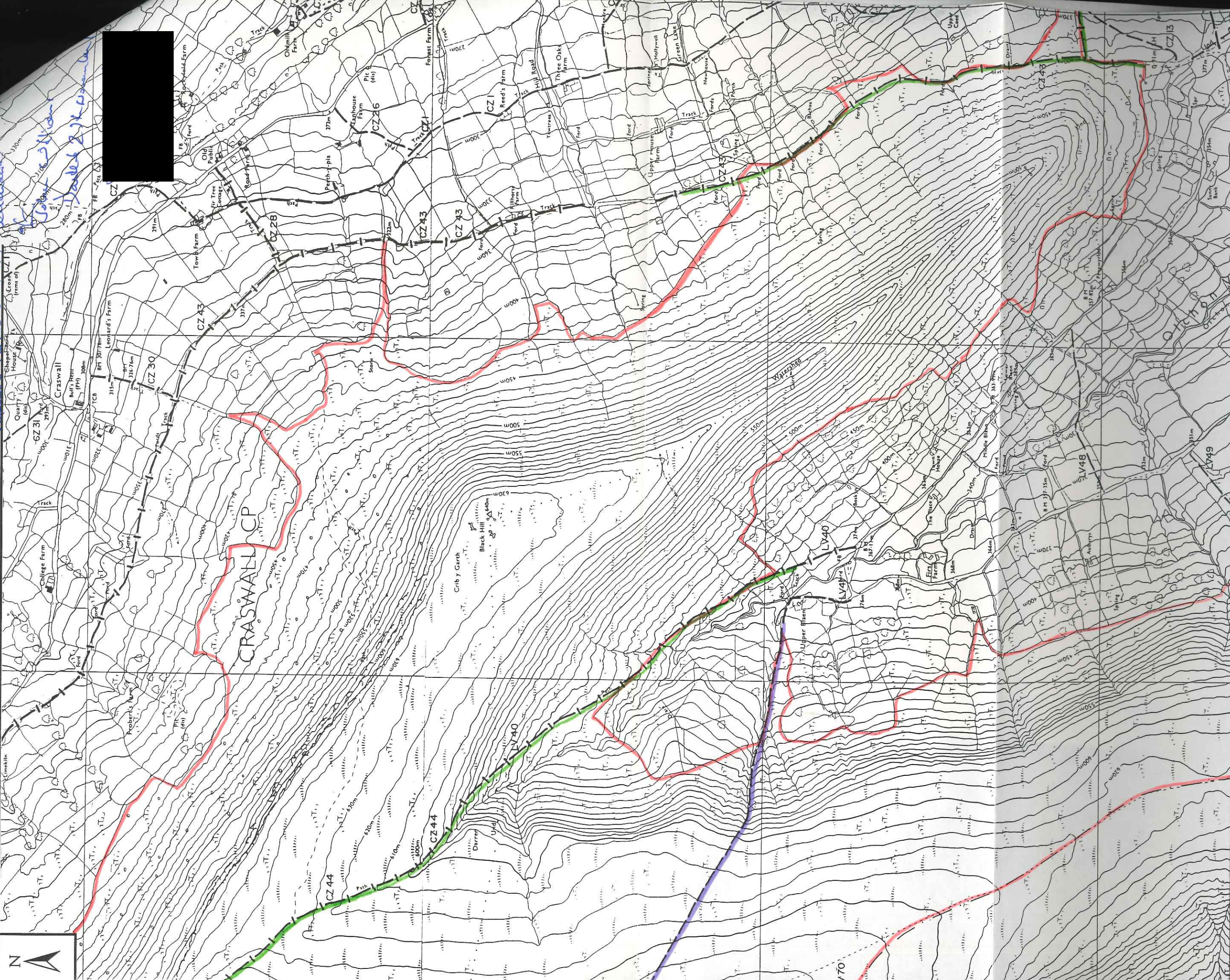
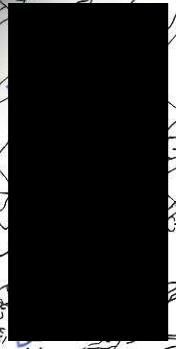
