STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) VAN STRAATEN DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since (day, month, year) 11th February 1994 the owner of the land known as (name of farm, etc) PARK FARM, CREDEXHILL more particularly delineated on the plan accompanying this declaration and thereon edged red.

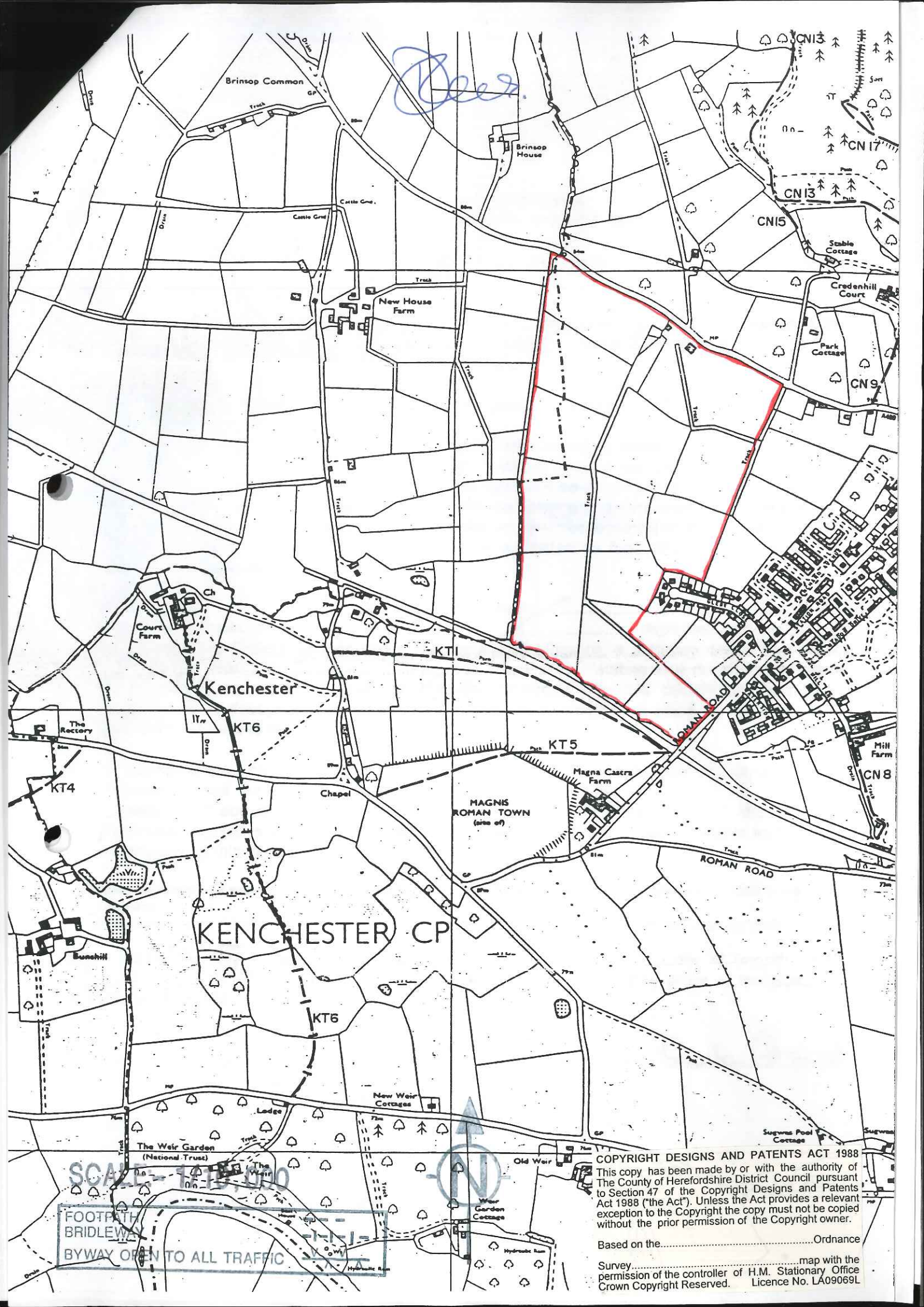

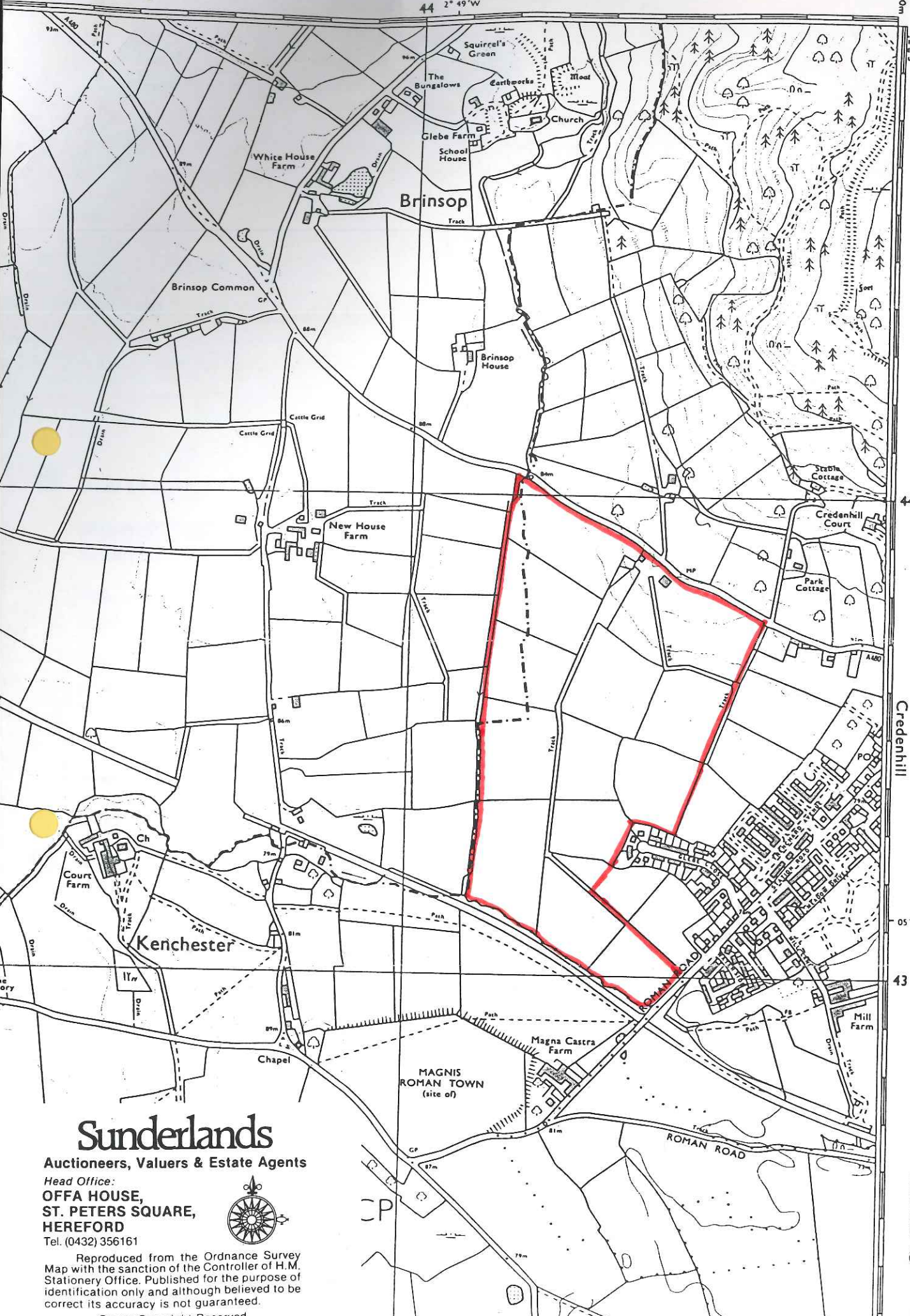
