STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) ELEANOR EVE KAY STRAATEN DO SOLEMNLY AND SINCERELY DECLARE as follows:

- 1. I am and have been since (day, month, year) 11th February 1994 joint the owner of the land known as (name of farm, etc) land at Court Farm and Park Farm more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the (day) 15th day of (month, year) September 1998 I (or my predecessor in title (name) ) deposited with the County of Herefordshire District Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as highways with vehicular status, the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways; the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths; no other ways had been dedicated as highways over my property.

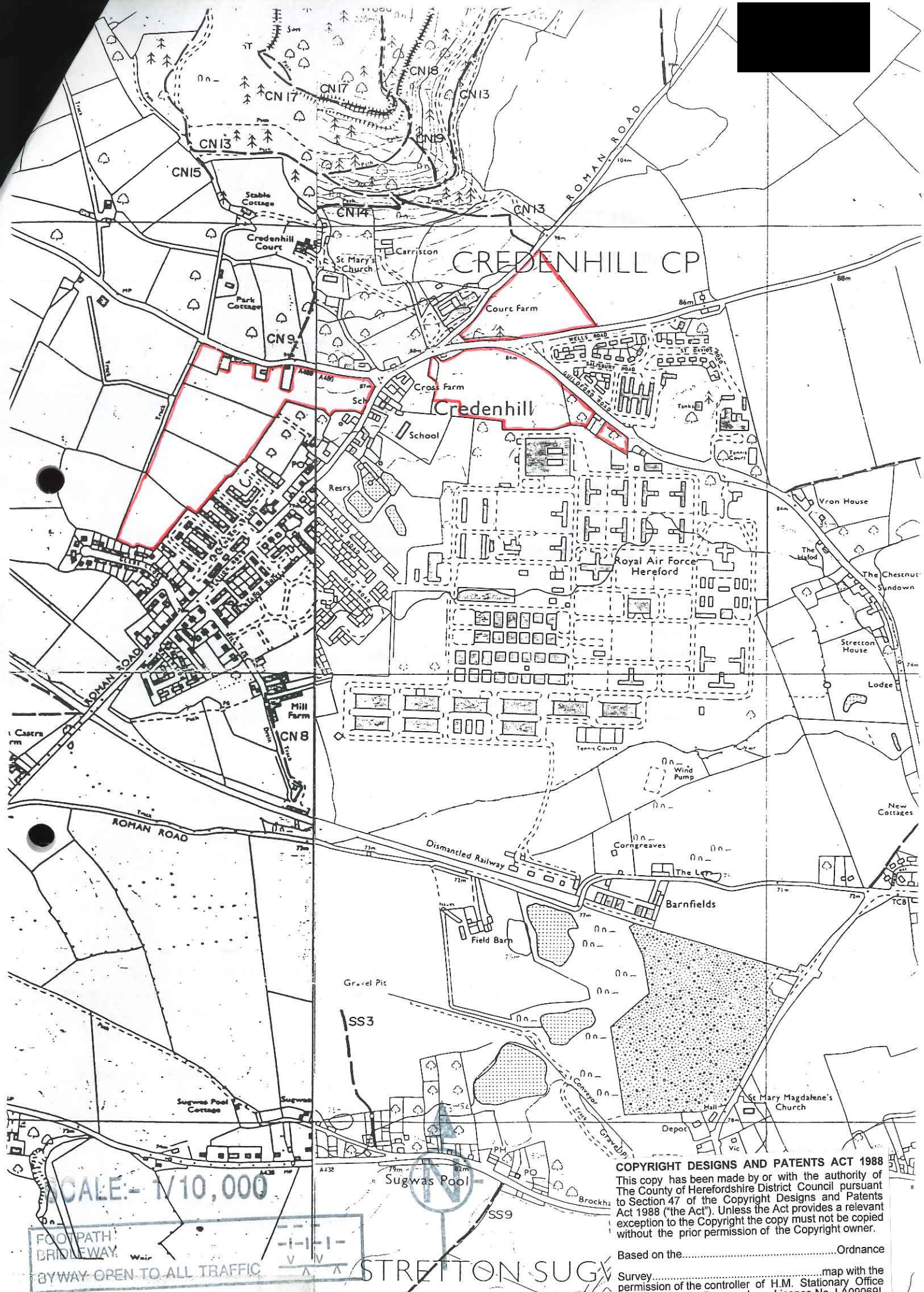
