

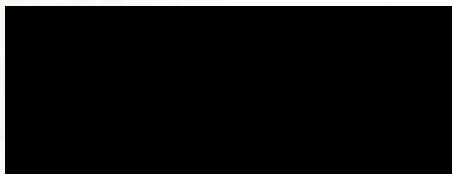

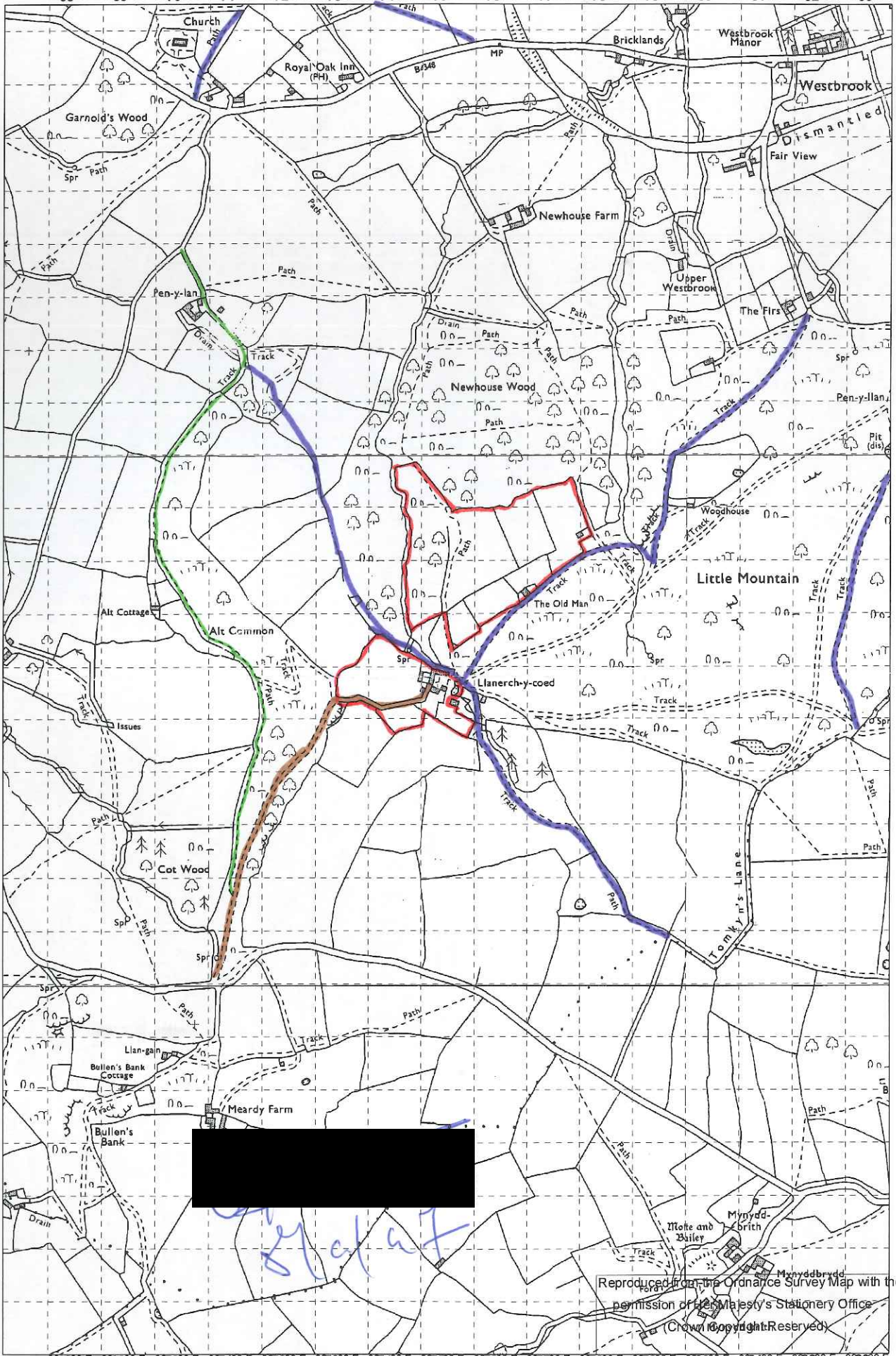

DECLARATION

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) GEORGEY JOHN LINKLATER & JANET LINKLATER DO SOLEMNLY AND SINCERELY DECLARE as follows:
