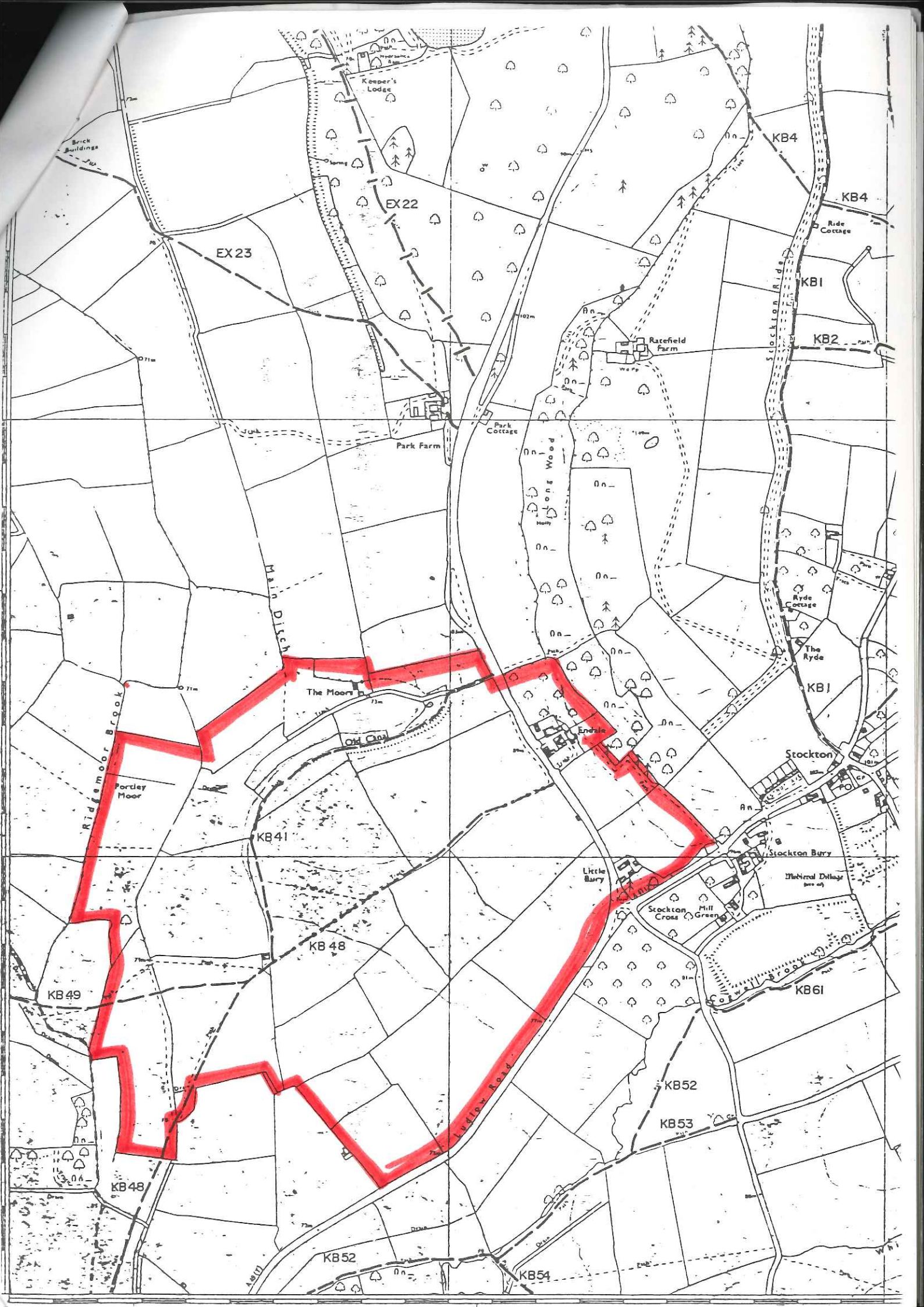

I wish to deposit with Hereford and Worcester County Council the accompanying map on which the land I own is shown delineated in red.

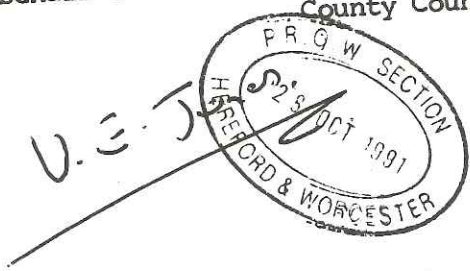
