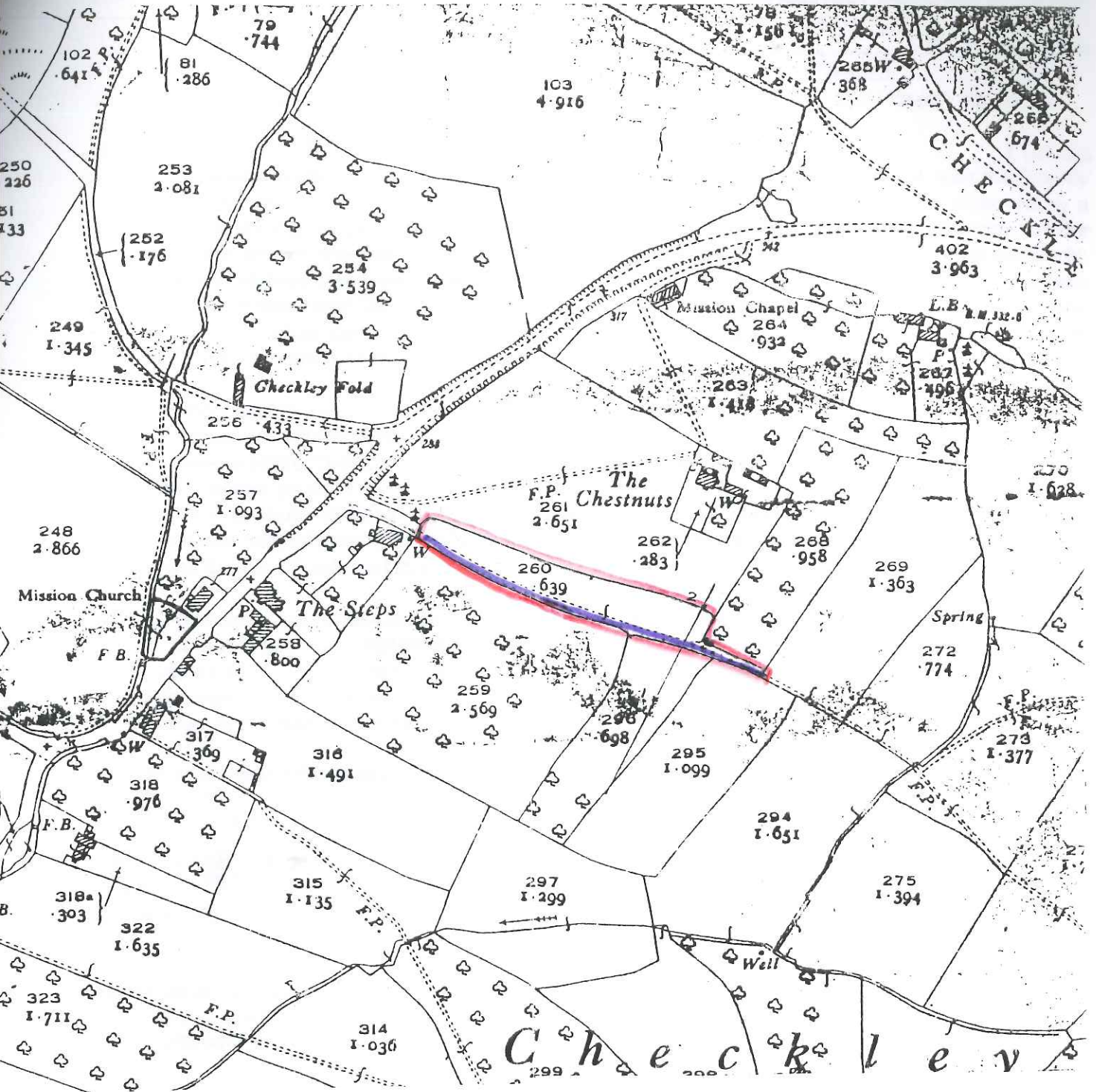

**STATUTORY DECLARATION  
SECTION 31 (6) OF THE HIGHWAYS ACT 1980**

I (landowner) NORMA MASSEY DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since (day, month, year) 1978 the owner of the land known as (name of farm, etc) BROOKSIDE PLOT more particularly delineated on the plan accompanying this declaration and thereon edged red.
