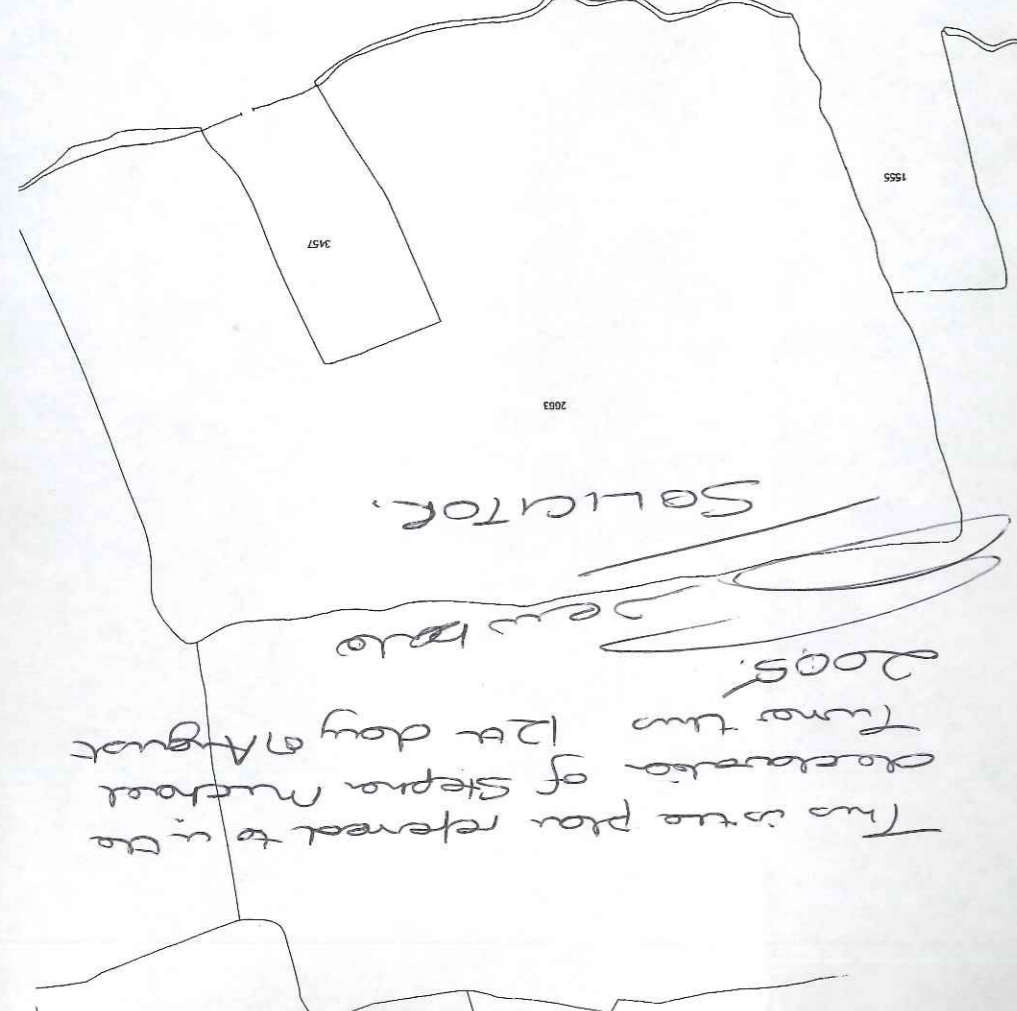



STATUTORY DECLARATION  
SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) Stephen Turner DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since (day, month, year) 5th July, 2005 the owner of the land known as (name of farm, etc) The Ussell's, Much Birch. more particularly delineated on the plan accompanying this declaration and thereon edged red.
