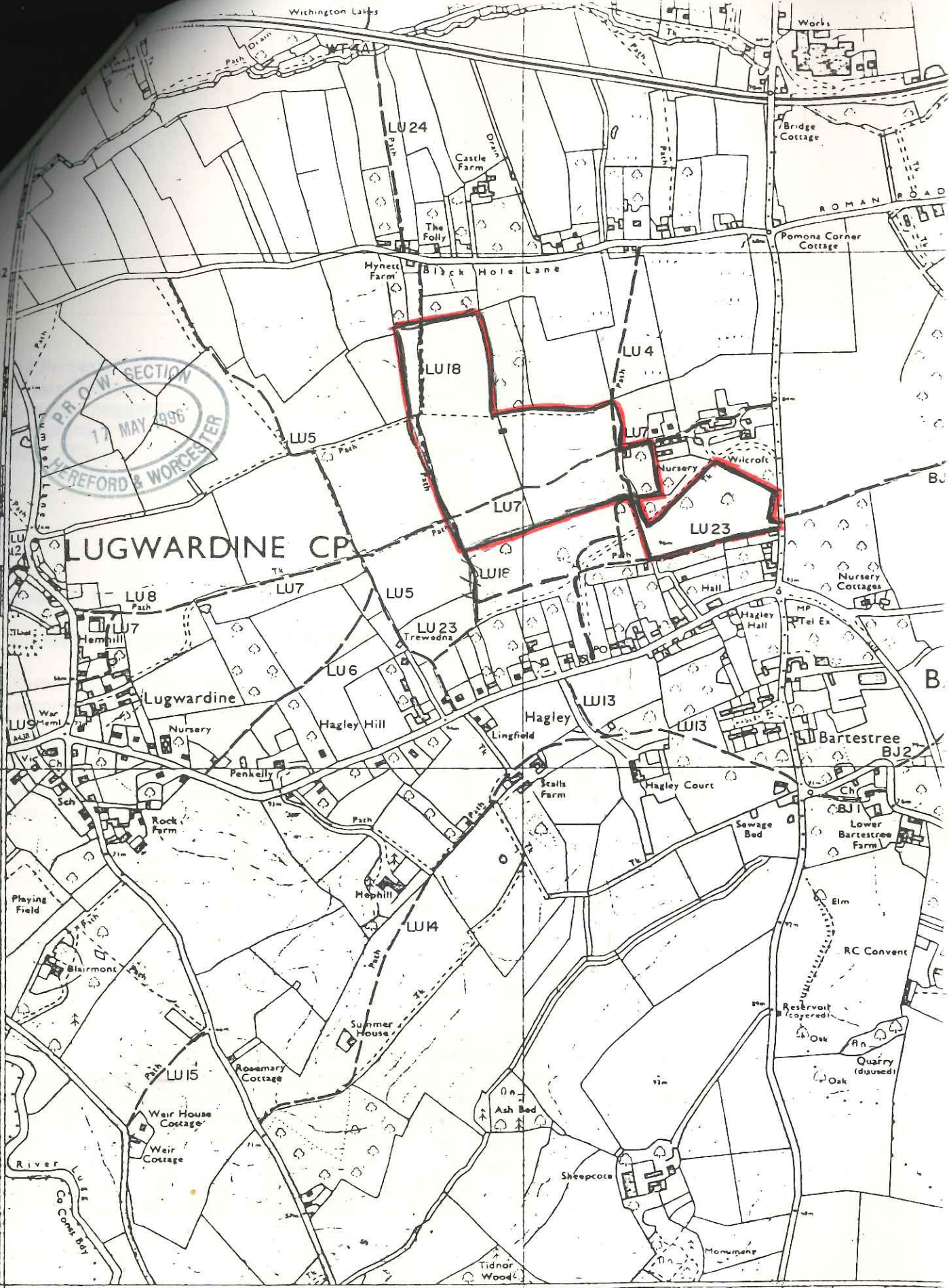

**STATUTORY DECLARATION
SECTION 31 (6) OF THE HIGHWAYS ACT 1980**
