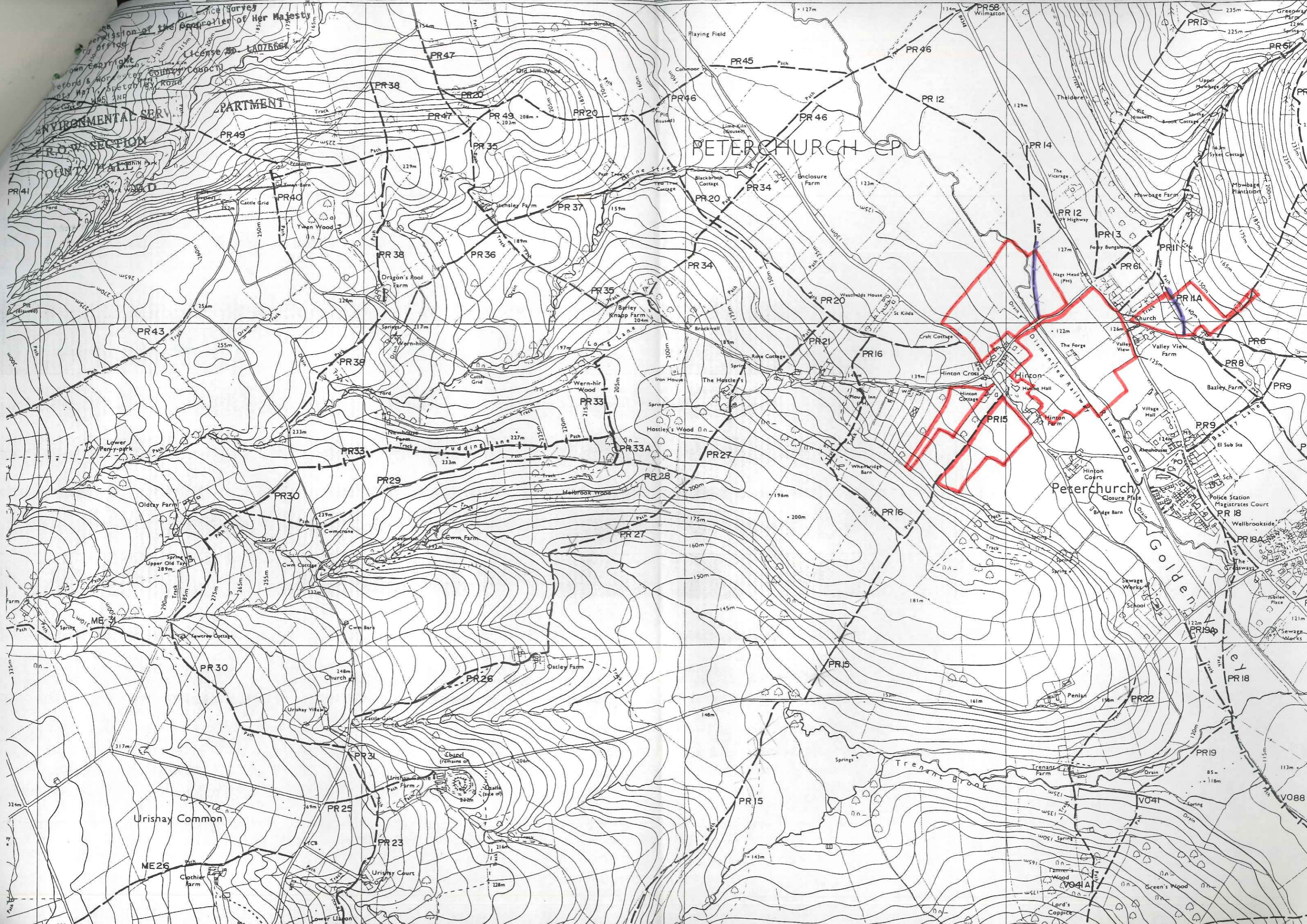

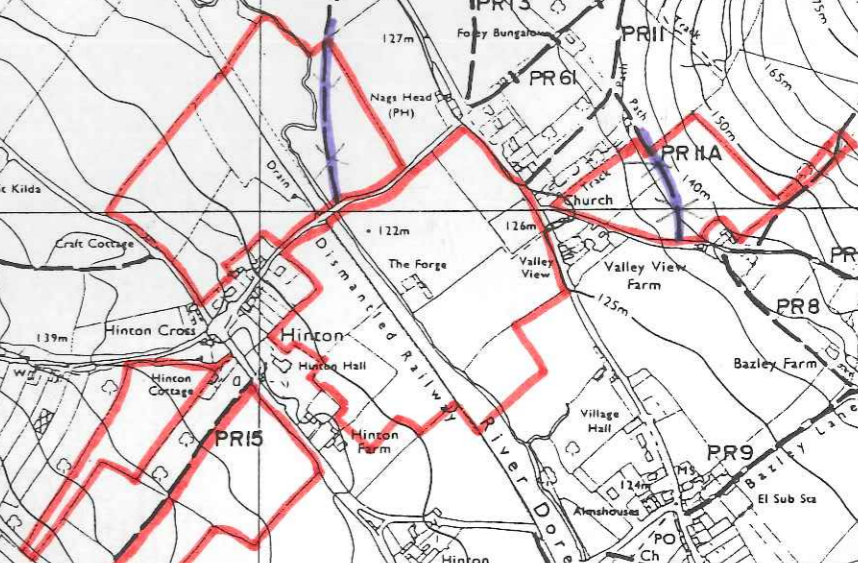

STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

I **GLYN IAN MORGAN** of Hinton Grange Peterchurch in the County of Hereford and Worcester do **SOLEMNLY AND SINCERELY DECLARE** as follows:

1. I am and have since the 31st December 1991 been the owner of the land being part of Valley View Farm and Hinton Farm Peterchurch aforesaid more particularly delineated on the map accompanying this Declaration and thereon edged red
2. On the 28th day of November 1997 I Glyn Ian Morgan deposited with Hereford and Worcester County Council, being the appropriate Council, a Statement accompanied by a map delineating my property by red edging which stated that the ways coloured purple on the said map and on the map accompanying this Declaration had been dedicated as footpaths and no other ways have been dedicated as highways over my property.
3. No additional ways have been dedicated on the land edged red on the map accompanying this Declaration since the Statement dated 14th November 1997 referred to in Number 2 above other than those footpaths marked in the appropriate colour on the map accompanying this Declaration and at the present time I have no intention of dedicating any more public rights of way over my property.
