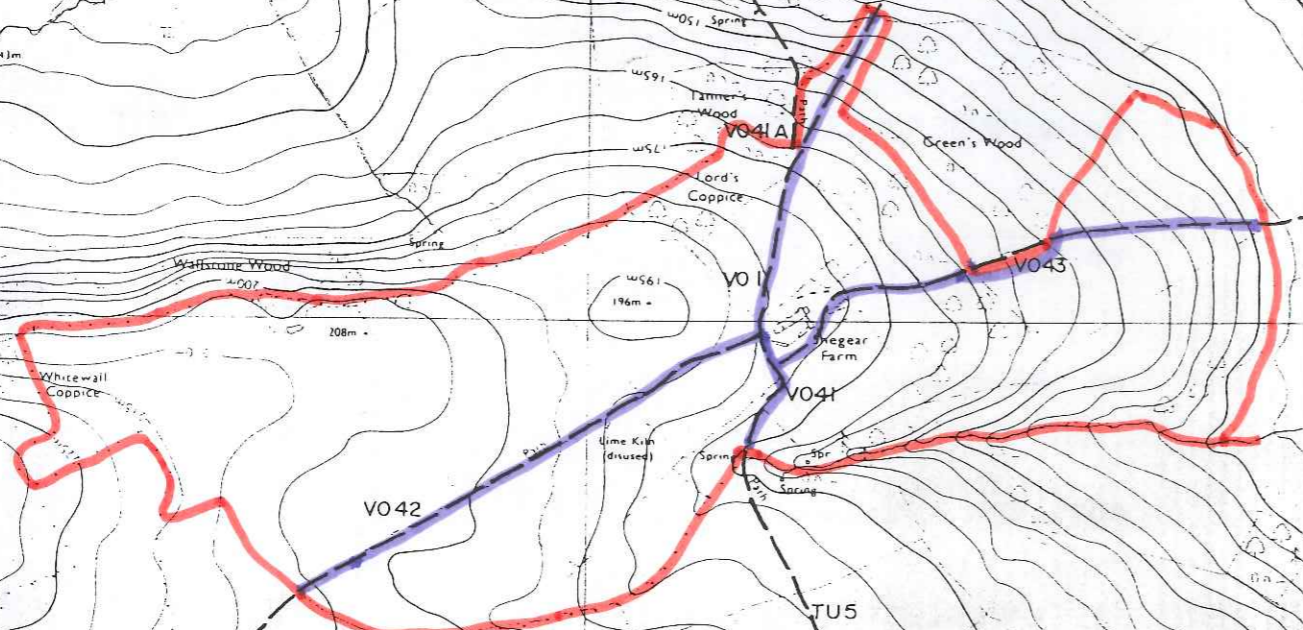
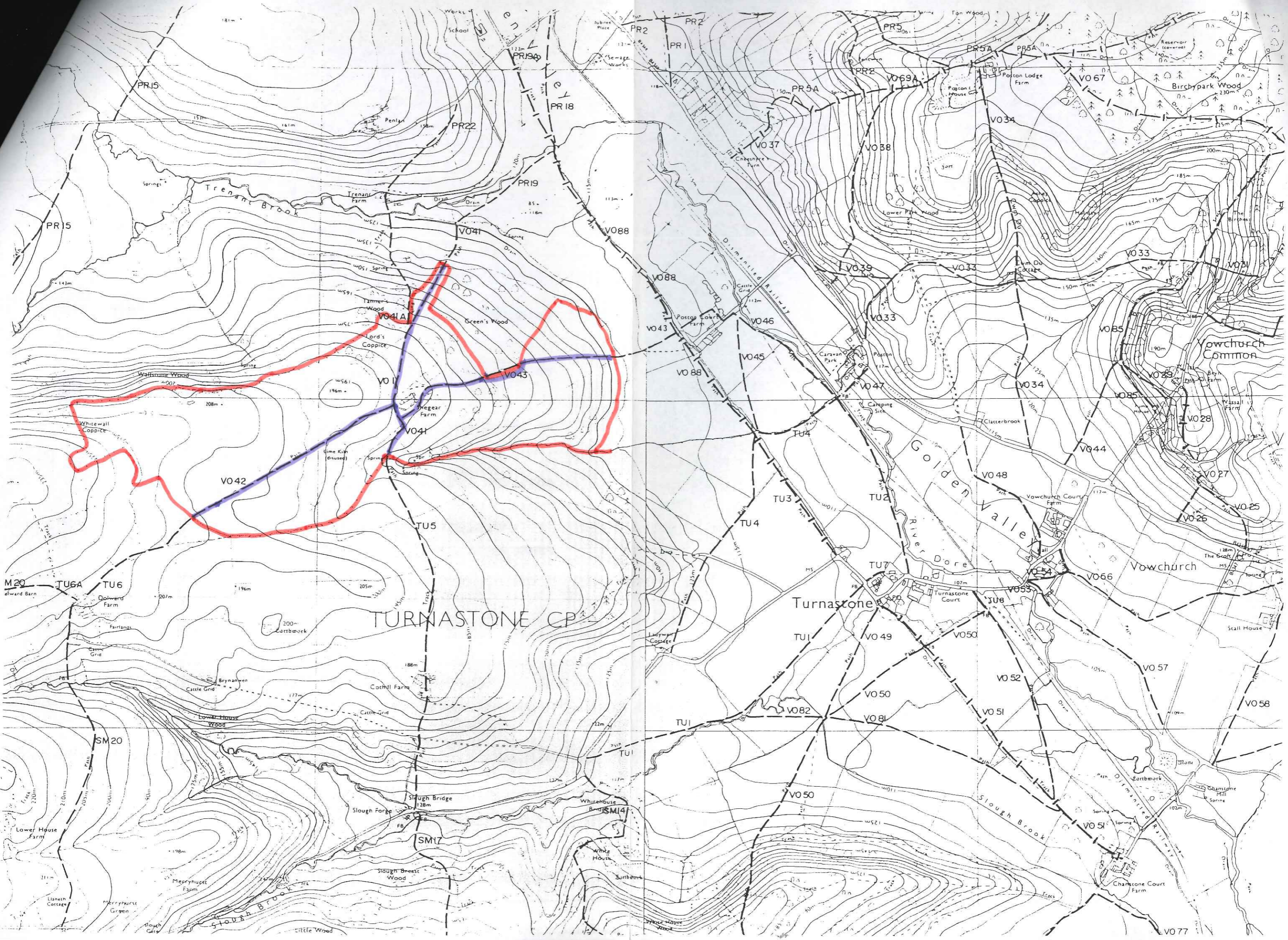

1. I am and have since 30th March 1995 been joint owner of the land known as Shegaer Farm Peterchurch more particularly delineated on the map accompanying this Declaration and thereon edged red.

2. On the 28th day of May 1997 I together with my brother WILFRED PRYCE JAMES deposited with Hereford and Worcester County Council, being the appropriate Council, a Statement accompanied by a map delineating my property by red edging which stated that the ways coloured green on the map accompanying this Declaration had been dedicated as bridleways and the ways coloured purple on the said map and on the map accompanying this Declaration had been dedicated as footpaths and no other ways have been dedicated as highways over my property.

No additional ways have been dedicated on the land edged red on the map accompanying this Declaration since the Statement dated 28th May 1997 referred to in Number 2 above other than those bridleways and footpaths marked in the appropriate colour on the map accompanying this Declaration and at the present time I have no intention of dedicating any more public rights of way over my property.
