

STATUTORY DECLARATION
SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I JULIAN MICHAEL PARTRIDGE of Upper Pengethley Farm Ross on Wye Herefordshire DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 16th March 1998 the owner of the land known as Upper Pengethley Farm Ross on Wye Herefordshire HR9 6LL more particularly delineated on the plan ("the Plan") accompanying this declaration and thereon edged red

On the 15th day of ~~December~~ 1999 I deposited with the County of Herefordshire District Council being the appropriate Council a Statement accompanied by a plan delineating my property by red edging which stated that the way coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways and the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths no other ways had been dedicated as highways over my property

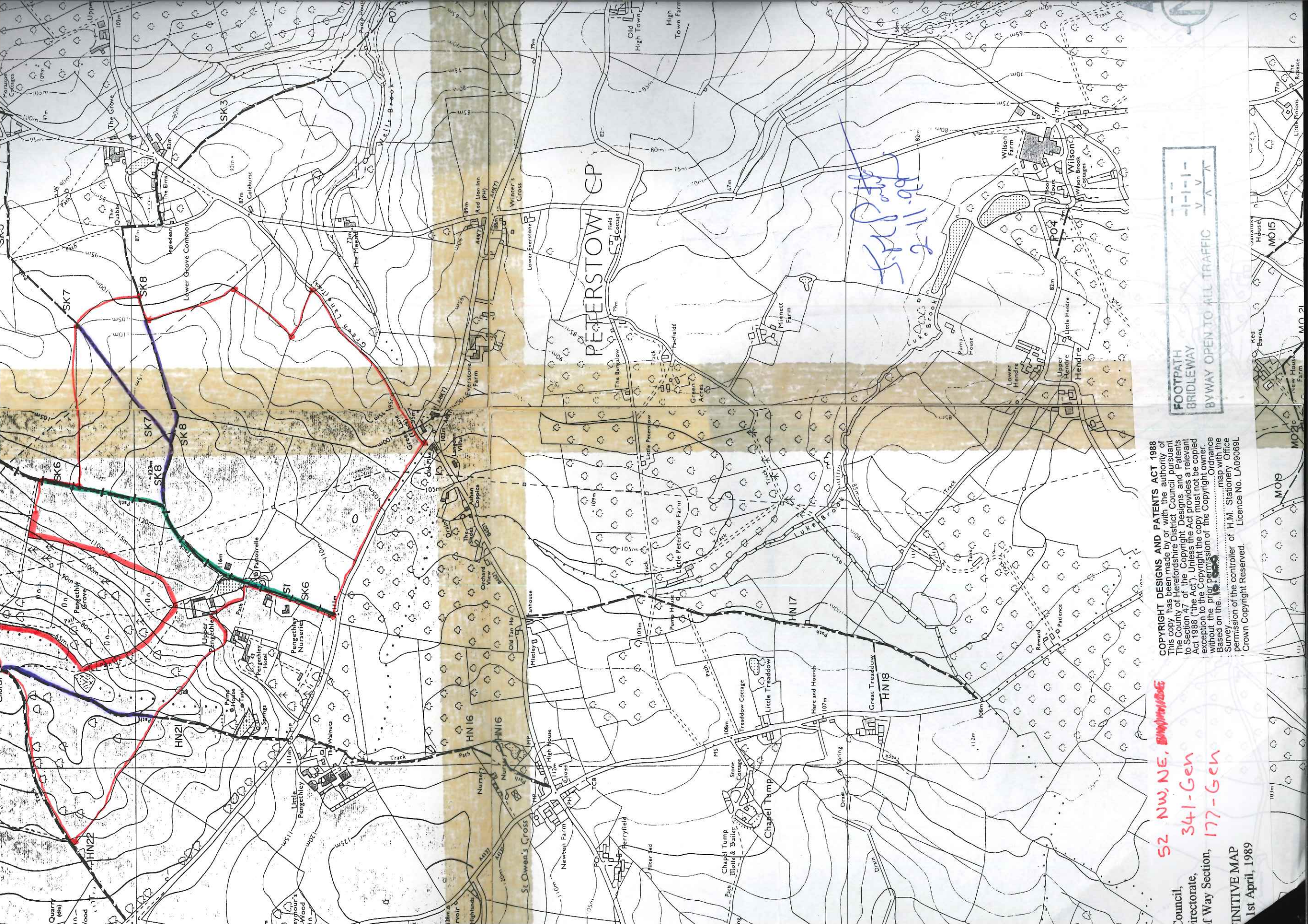
