1. We are Tenbury, Worce. WR15 8QS I am and have been since (day, month, year) 21st July 2005 the owner of the land known as (name of farm, etc) Lodge Farm, Broadheath, Tenbury, Worce. WR15 8QS more particularly delineated on the plan accompanying this declaration and thereon edged red.

2. On the (day) 12th day of (month, year) September 1990 we (or my predecessor in title (name) Owen James Edward Skynon) deposited with the County of Herefordshire District Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that [the ways coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as highways with vehicular status], [the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways], [the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths]; [no other] ways had been dedicated as highways over my property.
