**HIGHWAYS ACT 1980
NOTICE**

The Minister of Agriculture, Fisheries and Food hereby deposits with Hereford & Worcester County Council the accompanying map on which the land vested in him and placed at the disposal of the Forestry Commissioners in the County of Hereford & Worcester (or district of The Warren (Wapley) being part of the County of Hereford & Worcester) is shown delineated in red.

The Minister admits that the ways shown on the said map by Hereford & Worcester County Council are public rights of way within the provisions of Part IV of the National Parks and Access to the Countryside Act 1949. The Minister denies that there are any other such public rights of way over the land vested in him and shown on the said map.

For the purpose of this notice the Minister and the Hereford & Worcester County Council hereby agree that sub-section (6) of section 31 of the Highways Act 1980 shall apply to the land vested in the Minister and shown delineated in red on the said map.

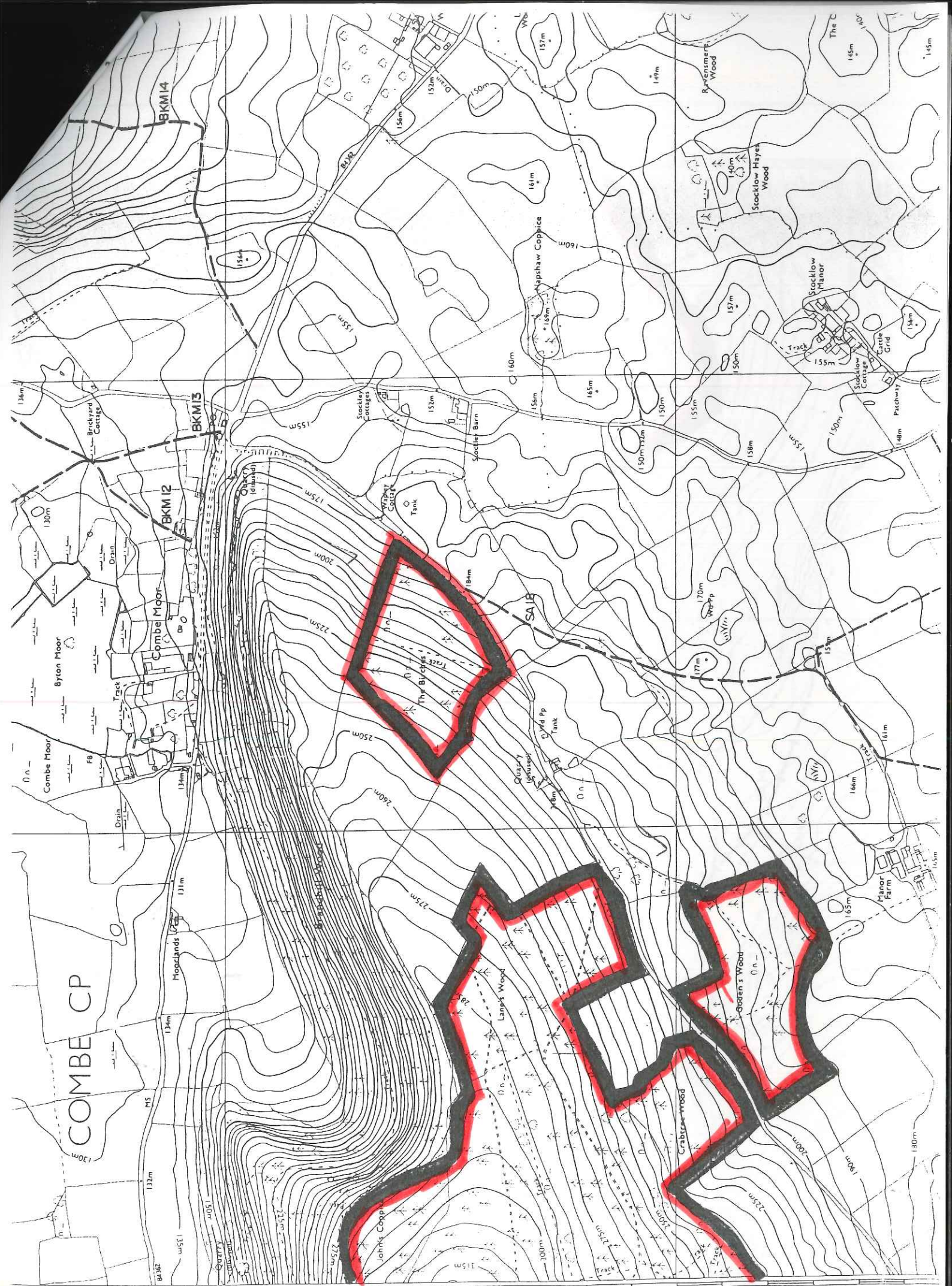
