STATUTORY DECLARATION


HIGHWAYS ACT 1980 SECTION 31 (6)

1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 12<sup>th</sup> April 1983 the owner of the land known as Woodland at Symonds Yat, Ross-on-Wye, Hereford more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 6<sup>th</sup> January 1989 the Woodland Trust deposited with Hereford and Worcester County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that no ways had been dedicated as highways over our property.

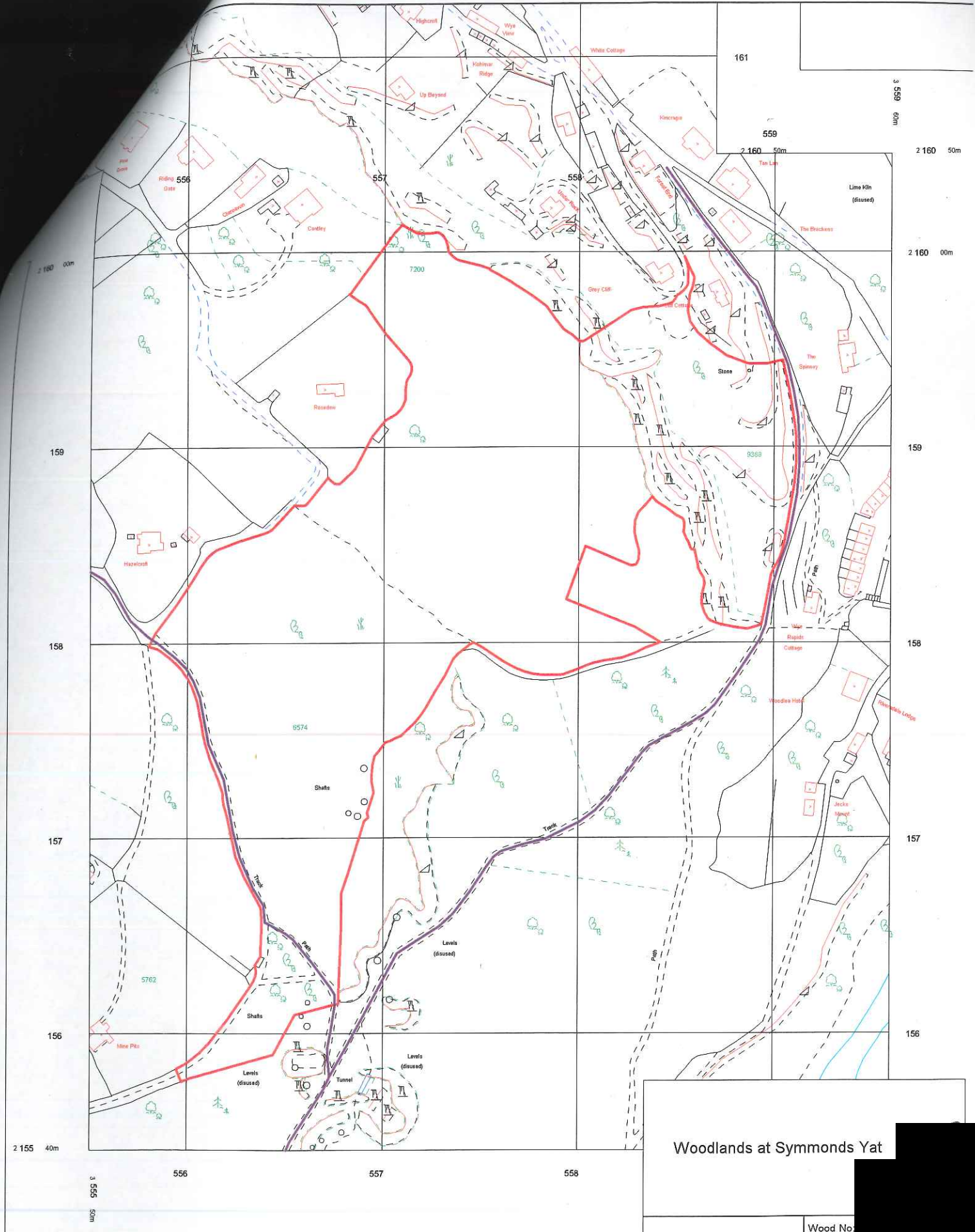

Woodlands at Symmonds Yat

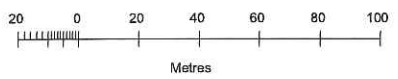


