

**STATUTORY DECLARATION
SECTION 31 (6) OF THE HIGHWAYS ACT 1980**

I (landowner) William Evans DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since (day, month, year) 1st MARCH 1985 the owner of the land known as (name of farm, etc) THE WHITBORENE ESTATE more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. - 4.** No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated (day, month, year) referred to in 2 above [since the date of the statutory declaration referred to in 3 above] [other than those (highways with vehicular status) (bridleways) (footpaths) marked in the appropriate colour on the plan accompanying this declaration]

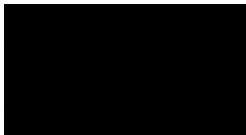
