STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I (landowner) Ave Anthony Smolas DO SOLEMNLY AND SINCERELY DECLARE as follows:

- 1. I am and have been since (day, month, year) 8 SEPTEMBER 2010 the owner of the land known as (name of farm, etc) LLANERCH Y COED DORSTONE HEREFORD HR3 6AA more particularly delineated on the plan accompanying this declaration and thereon edged red.
- 2. 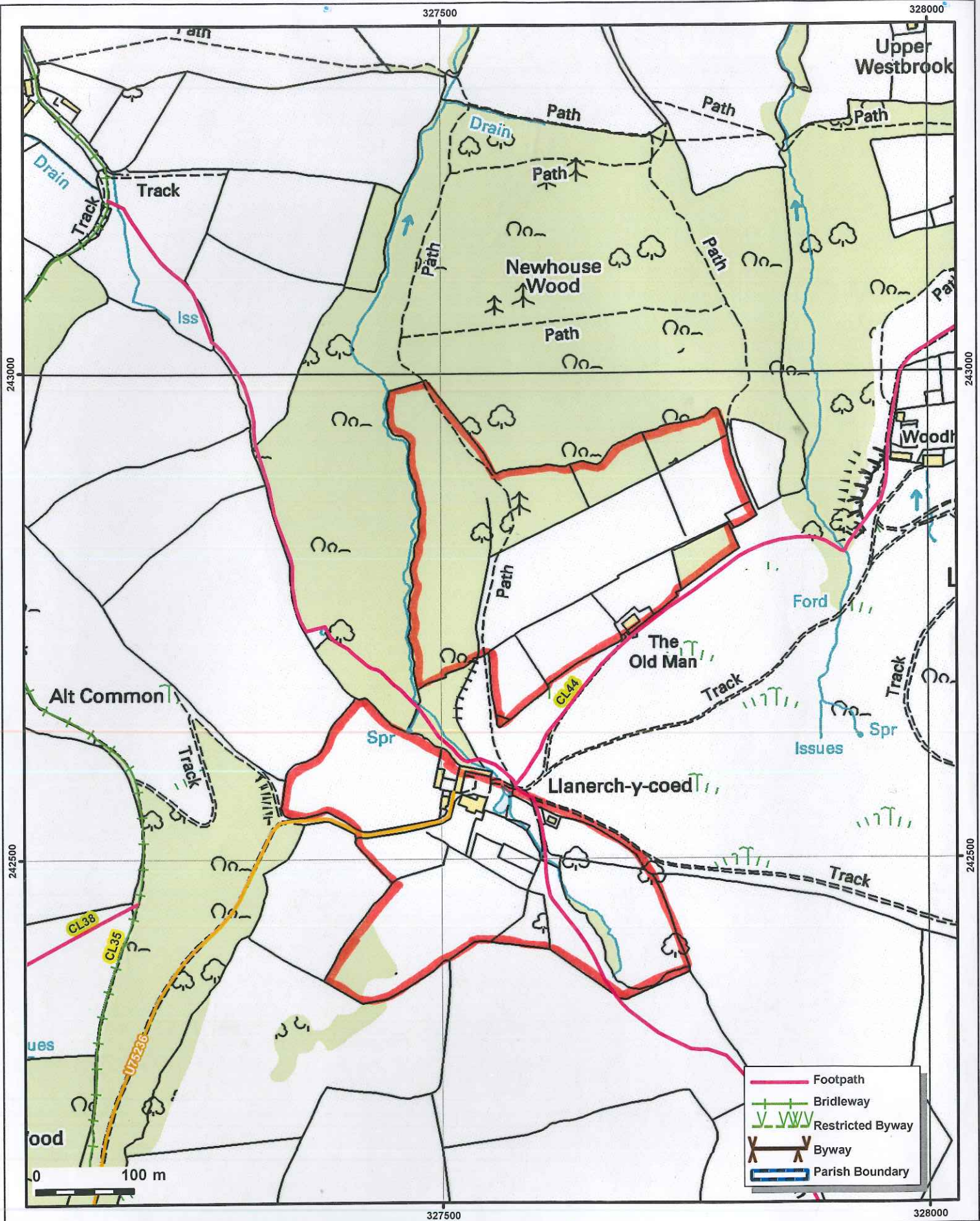
