SECTION 31 (6) OF THE HIGHWAYS ACT 1980



**STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980
(as amended by the Countryside and Rights of Way Act 2000)**

We, **Mr and Mrs Christopher Evans** DO SOLEMNLY AND SINCERELY DECLARE as follows;

1. We are and have been since 1985 the owner of the land known as **Lady Arbour Court Winforton Herefordshire HR3 6BB** more particularly delineated on the map accompanying this declaration and thereon edged red.
2. On the 18th day of December 2012 deposited with **Herefordshire county council**, being the appropriate Council, a statement accompanied by a map delineating my property by red edging which stated the [the ways coloured brown on the said map and on the map accompanying this declaration had been dedicated as highways with vehicular status] [the ways coloured green on the said map and on the map accompanying this declaration had been dedicated as bridleways] [the ways coloured purple on the said map and map accompanying this declaration had been dedicated as footpaths] [no (other) ways had been dedicated as highways over my property].
3. On the 20th day of December 2012 deposited with Herefordshire County Council, being the appropriate Council, a statutory declaration stating that no additional ways [other than those marked in the appropriate colour on the map accompanying this declaration] had been dedicated as [highways with vehicular status] [bridleways] [footpaths] since the deposit of the Statement referred to in (2) above.
4. No additional ways have been dedicated over the land edged red on the map accompanying this declaration since the statement dated 18th December 2012 referred to in (2) above [since the date of the statutory declaration referred to in (3) above] [other than those (highways with vehicular status) (bridleways) (footpaths) marked in the appropriate colour on the map accompanying this declaration] at the present time I have no intention of dedicating any more public rights of way over my property.

AND I MAKE this solemn declaration on the 20th day of December 2012 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.
